## Good Morning Laura.

Thanks for removing the outdated schedule information from section 8 of the proposal as requested by John Cook. John also mentioned that he wanted to clarify that SNL would host a meeting for the peer review group on the NUREG and would support a public meeting on the NUREG. If SNL agrees, please include this in section 5. The statement that SNL is doing work on RADTRAN and that SNL does not view this work as constituting a conflict of interest does not meet the organizational conflict of interest (OCOI) disclosure requirements of the NRC.
