Onsite Emergency Response Capabilities; Draft Regulatory Basis; 10 CFR Parts 50 and 52 (RIN 3150-AJ11; NRC-2012-0031)

On January 8, 2013, the NRC published a document in the *Federal Register* (78 FR 1154) issuing for public comment a draft regulatory basis to support the potential amendment of its regulations concerning nuclear power plant licensees' onsite emergency response capabilities. The issuance of this draft regulatory basis document is one of the actions stemming from the NRC's lessons-learned efforts associated with the March 2011 Fukushima Dai-ichi Nuclear Power Plant accident in Japan. The public comment period closes on February 22, 2013.

<u>Unified Agenda of Federal Regulatory and Deregulatory Actions; Semiannual Regulatory</u> Agenda; 10 CFR Ch. 1

On January 8, 2012, the NRC published the Semiannual Regulatory Agenda (the Agenda) in the *Federal Register* (78 FR 1704) in accordance with Public Law 96-354, "The Regulatory Flexibility Act," and Executive Order 12866, "Regulatory Planning and Review." The Agenda is a compilation of all rules on which the NRC has recently completed action or has proposed or is considering action. This issuance updates any action occurring on rules since publication of the last semiannual agenda on February 13, 2012 (77 FR 8078).

Enhanced Weapons, Firearms Background Checks, and Security Event Notifications; Supplemental Proposed Rule; 10 CFR Part 73 (RIN 3150-Al49; NRC-2011-0018)

On January 10, 2013, the NRC published a supplemental proposed rule in the *Federal Register* (78 FR 2214) proposing regulations that would implement authority under Section 161A of the Atomic Energy Act of 1954, as amended, and revise existing regulations governing security event notifications. The NRC proposed new regulations on February 3, 2011 (76 FR 6199), that would implement its authority under Section 161A. The NRC is now proposing to further revise its regulations that address the voluntary application for enhanced weapons authority, preemption authority, and mandatory firearms background checks under Section 161A to include as a class of designated facilities: at-reactor, independent spent fuel storage installations. Comments on this supplemental proposed rule must be submitted by February 25, 2013. Comments specific to the information collection burdens of this supplemental proposed rule must be submitted by February 11, 2013.

Publication of Regulatory Guide 4.22, "Decommissioning Planning During Operations"

On January 4, 2013, the staff announced in the *Federal Register* the availability of Regulatory Guide (RG) 4.22 "Decommissioning Planning During Operations (78 FR 663, Vol 78, Number 3, pg. 663)." This RG was developed to provide guidance for implementing portions of the Decommissioning Planning Rule (DPR) which became effective on December 17, 2012. The DPR is intended to improve decommissioning planning and reduce the likelihood that any currently operating facility subject to the DPR will become a legacy site that lacks the means to complete decommissioning. National Academy of Sciences Inaugural Meeting of the Site Characterization, Modeling, Monitoring, and Remediation Study Committee

On January 7, 2013, RES staff, accompanied by staff from the Office of Nuclear Reactor Regulation, the Office of New Reactors, and the Office of Federal and State Materials and Environmental Management Programs, attended and presented their perspective on a new National Academy of Sciences (NAS) study committee focusing on site characterization, modeling, monitoring, and remediation (SCMMR) in fractured rocks. The NRC, Department of Energy, and National Aeronautical and Space Administration are supporting the study. The study includes organizing and conducting a workshop on SCMMR in fractured rock. This meeting focused on the sponsors' expectations through a dialogue with the NAS committee members. RES staff will monitor the NAS grant study and will provide both information to the NAS committee as requested, and information back to the NRC staff on the workshop details.
