Dear Sir or Madam,

On October 12, 2012, EnergySolutions Spent Fuel Division (ES-SFD) submitted the reference 1 application to NRC requesting renewal of Certificate of Compliance (CoC) No. 72-1007 for the VSC-24 Ventilated Dry Cask Storage System. Per the referenced 2 letter, NRC requested that ES-SFD provide supplemental information needed for NRC staff to continue their review of the VSC-24 CoC renewal application. In the reference 2 letter, NRC requested that the response to the request for supplemental information (RSI) be provided by February 1, 2013.

In previous discussions between ES-SFD (S. Sisley) and NRC (P. Longmire, Ph.D.), ES-SFD informed NRC that, due to prior scheduling commitments in late January 2013 and the need for GL review and concurrence with the RSI response, the typical RSI response period of 15-days might not be sufficient. ES-SFD understood from those discussions that the RSI response due date could be extended, provided that it was discussed in advance with NRC and confirmed in a letter to NRC.

During subsequent communications between ES-SFD (S. Sisley) and NRC (P. Longmire, Ph.D.) on January 21 and January 28, 2013, ES-SFD requested a two-week extension of the due date for submittal of the RSI response. This letter provides confirmation of those communications. ES-SFD will provide the RSI response to NRC by February 15, 2013.
