SUBJECT: APPLICATION FOR AMENDMENT TO THE MODEL NO. NAC-LWT –
SUPPLEMENTAL INFORMATION NEEDED

Dear Mr. Patko:

By letter dated December 28, 2012, NAC International submitted an application for approval of high enriched uranyl nitrate liquid as approved contents in the Model No. NAC-LWT transport package. Staff performed an acceptance review of your application to determine if the application contains sufficient technical information in scope and depth to allow the staff to complete the detailed technical review.

This letter is to advise you that based on our acceptance review, the application does not contain sufficient technical information. The information needed to continue our review is described in the enclosure to this letter as Request for Supplemental Information and Observations. Staff included observations to allow you to start earlier on items containing the potential to be asked at a later date. Responses to observations are not required for staff to begin a detailed technical review. Observations are not the result of a detailed technical review and may be resolved once staff begins a detailed review.
