SUBJECT: SUMMARY OF PUBLIC TELECONFERENCE TO DISCUSS STATUS  
OF WASTE CONFIDENCE ENVIRONMENTAL IMPACT STATEMENT  
AND RULEMAKING

On Wednesday, January 16, 2013, members of the U.S. Nuclear Regulatory Commission (NRC) staff held a public teleconference at the NRC headquarters in Rockville, Maryland. The teleconference was the first in a planned series of monthly public teleconferences to provide an update on the activities related to the Waste Confidence rulemaking and preparation of the environmental impact statement (EIS) that will support the revised Waste Confidence rule. The purpose of the meeting was for the NRC staff to share information with the public and to allow participants to ask questions about the process for the activities underway.

The meeting began at 1:30 p.m. EST and concluded at 2:30 p.m. EST. The meeting opened with a brief overview of the recently completed public scoping period followed by a status update on the draft EIS. Staff then discussed future public participation opportunities before opening the teleconference lines for questions.

There were 101 participants in the meeting representing members of the public, tribal and state governments, industry, public advocacy groups and the Nuclear Regulatory Commission and its contractors. Of the 76 members of the public who participated, 9 asked questions during the teleconference. A list of meeting participants is included as Attachment 1.

Concerns, questions, and issues discussed during the teleconference included: how the scoping comments that have been received are being organized and when all comments will be available for public review; the locations, format, and number of future public meetings to discuss the draft EIS; clarification of Commission involvement in this process; notification that the Scoping Summary Report is scheduled to be available in early March to address scoping comments and clarify the scope of the EIS; concern that there aren't enough public meetings planned in communities that could be affected by issues such as transportation and centralized interim storage; how non-power reactor license renewals will be affected by the Waste Confidence rule; consideration of Department of Energy documents (such as Yucca Mountain-
