Dear Mr. Rakowski:

Enclosed is Amendment No. 59 to your NRC Materials License No. 21-04127-06 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

In your letter dated November 19, 2012, you requested that we remove certain individuals as authorized users and authorized medical physicists. Also, you requested to remove iodine-125 and lotrex from the authorized materials listing. We have made these deletions from your license. In addition, in your letter dated November 29, 2012, you requested to add another authorized medical physicist and we have made that addition as well.

Further, as part of this license amendment, we requested information from you regarding certain brachytherapy sources so that we might further clarify your authorized materials listing. You provided the necessary information in letters dated January 18 and 23, 2013. We thank you for your cooperation in that matter.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U. S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

You will be periodically inspected by NRC. Failure to conduct your program in accordance with NRC regulations, license conditions, and representations made in your license application and supplemental correspondence with NRC will result in enforcement action against you. This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions. Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.

The NRC's Safety Culture Policy Statement became effective in June 2011. While a policy statement and not a regulation, it sets forth the agency's *expectations* for individuals and organizations to establish and maintain a positive safety culture. 
