Salazar Issues Cape Wind Construction Plan

In the latest regulatory milestone advancing the nation's first offshore wind farm, Interior Secretary Ken Salazar Tuesday announced that the department's offshore leasing agency has approved a construction and operation plan for the Cape Wind project off the coast of Massachusetts, clearing a path for the project's developers to start building later this year.

The decision comes seven months after Salazar signed the lease for the 468 megawatt, 130-turbine project planned by Boston-based developer, Cape Wind Associates LLC. The time frame included in the construction plan submitted by the developer suggests that construction could begin as early as this fall.

The signing of the 28-year lease for the Cape Wind project ended an eightyear struggle by its developer to get needed federal and state permits and overcome opposition from some environmental, native peoples and homeowner groups on Cape Cod who objected to the erection of towering turbines on Horseshoe Shoal in Nantucket Sound.

In a nod to those lingering concerns, Salazar said Tuesday that Interior's Bureau of Ocean Energy Management, Regulation and Enforcement "has taken extraordinary steps to fully evaluate Cape Wind's potential impacts on environmental and cultural resources of Nantucket Sound. By signing the construction and operations plan today, we are even closer towards ushering in our nation's first offshore wind energy facility while creating jobs."

Moving to address problems clearly illustrated by the Cape Wind project, the Interior Department has proposed streamlining its offshore wind leasing process by identifying high-priority "wind energy areas" in the Atlantic Ocean seen by the department as less likely to pose environmental issues or conflicts with defense or other maritime activities.

Interior said in a statement the agency approved construction plans "substantially the same as analyzed" in its final environmental review of the project issued in January 2009.

However, the agency said project developers must follow various "terms and conditions" in addition to those established in the lease agreement that build upon some 160 public comments gathered by Interior earlier this year. Those comments concern, among other things, conflicts with fishing use, migratory birds and oil within wind turbine generators.

Shell plc said industry is also moving to address the apparent shortcomings of BOPs. Charlie Williams, chief scientist for well engineering and production technology at Shell and a member of Interior's newly established Ocean Energy Safety Advisory Committee, told the CSIS forum that industry leaders are working to make recommended practices for BOP equipment into strict standards.

"This has a lot of benefits, but one of them is... you remove this discussion about which option should you choose" regarding pressure controls and maintenance, Williams said.

A forensic analysis of BP's failed BOP conducted by Norwegian consultancy Det Norske Veritas (DNV) found that high-pressure forces from beneath the well likely caused the drill pipe to buckle within the wellbore, realigning it such that the BOP's blind shear rams could not cut or crush the pipe as designed and stem a massive outpouring of hydrocarbons.

The consultancy's analysis, requested by Interior and released by the agency last month, largely absolves BP's BOP as a causal factor in the Gulf spill.

However, the report recommended industry "review and revise as necessary" requirements and procedures for periodic testing of BOP back-up control systems after finding that some of those components of BP's device "did not perform as intended."

However, that assessment has since been disputed by a BP consultant and a senior official with Cameron, the Houstonbased company that built and designed BP's BOP.

Ralph Linenberger, who represented BP in the technical working group that analyzed the device at NASA's Michoud facility in New Orleans after it was raised from the sea floor, told federal investigators April 8 that it was "not evident" to him that the failure of the blind shear rams to close around the drill pipe was due to repositioning of the drill pipe.

However, in testimony before a hearing held by BOEMRE and the U.S. Coast Guard in Metairie, La., Linenberger said his conclusion was based on limited data provided to the working group by DNV, whom he said "were the ones that were reading the [BOP] gauges.

"We were not allowed to get that close to the equipment due to safety issues," he said.

However, Linenberger added: "It was only about a [four-foot, two-inch] section of pipe and it looked fairly straight to me."

Linenberger also said DNV investigators failed to consider whether insufficient maintenance of the BOP may have been a key factor in the device's failure.

Comments from a high-ranking Cameron official the same day also failed to clarify matters.

David McWhorter, Cameron's vice president and also a member of the BOP technical working group, said that the BOP was never tested to see if it would cut through an offcenter drill pipe, adding that he was unwilling to "hazard an opinion" about such a test.

However, when asked for an opinion as to why the BOP failed to operate as designed, McWhorter, an engineer, said: "I don't have any specific knowledge about that, no."

Perhaps the comments that muddled matters the most came from DNV officials.

Neil Thompson, a U.S. DNV representative, testified April 4 that DNV engineers did not actually test the failed BOP's blind shear rams, but instead used only computer modeling, casting further doubt about the report's conclusions.

Interior is conducting its own study of BP's failed BOP that the agency will issue in the coming weeks.

Meanwhile, Interior Secretary Ken Salazar announced April 5 that Interior plans soon to propose new technical requirements for BOPs. However, in announcing the rulemaking plans on a call with reporters, Salazar said little about what the requirements might entail.

Salazar said BOP blind shear rams most likely will be scrutinized under the proposal, adding that Interior is currently "looking at what else might be needed" in the new rule.

Funded in part by an \$18 million Energy Department grant and a \$4 million grant from the state of Michigan, the API Alpena biorefinery originally was designed to demonstrate API's Greenpower+ process for making cellulosic ethanol

In a major biofuels advance, Cobalt from woody biomass extract produced at inologies and American Process Inc. the DPI plant.

As a result of the agreement announced Tuesday, the Alpena biorefinery also will demonstrate the commercial viability of Cobalt's biobutanol production process. The plant is slated to begin ethanol production in early 2012 and switch to biobutanol production in mid-2012. The facility will produce 470,000 gallons of biobutanol annually, which will be pre-sold to chemical partners.

API's Greenpower+ technology is a proprietary process for extracting hemicelluloses sugars from woody biomass using steam or hot water and converting them to fermentable sugars in a costeffective and technically robust process. The extracted biomass is returned—with consistent low-moisture composition—to the biomass boiler for the production of steam and/or electricity.

The process significantly increases the overall profitability of the site by con-

verting woody biomass into fermentable sugars that can then be converted to highvalue biofuels and biochemicals. The Greenpower+ technology is applicable to any industry employing biomass boilers or having organic effluent, API said.

Cobalt's technology converts sugars from non-food feedstock, such as forest waste and mill residues, into biobutanol. Cobalt's continuous biobutanol production system is based on advancements in biocatalyst selection, bioreactor design and process engineering, resulting in a highly productive, capital-efficient, lowcost method for producing biobutanol. In addition, the process is scalable, and reduces lifecycle greenhouse gas emissions by up to 90 percent compared to gasoline production.

Biobutanol is a versatile product that can be sold as is for use in paints, coatings and other chemical products; blended with gasoline, diesel or ethanol; or converted into bio-based plastics or full-performance jet fuel and diesel. Cobalt said it is making biobutanol and its derivatives a cost-effective substitute for petroleum-based materials.

[South Texas Project] project."

In a call with analysts, Crane said the Japanese crisis meant the South Texas Project (STP) faced "a period of almost total regulatory uncertainty for an unknown and potentially indefinite period of time."

As a result, the project is "not dead, but equally can not be effectively advanced," Crane said.

NRG said it expects its primary partner in the project— Toshiba America Nuclear Energy (TANE)—to continue seeking regulatory approvals for the STP expansion. TANE officials were not immediately available for comment Tuesday.

While nuclear companies across the world are watching with alarm the continuing crisis at Japan's Fukushima Daiichi nuclear plant, the STP project has always been particularly dependent upon Japanese public and private sector support that now seems highly unlikely.

The NRG-led partnership developing the STP project, known as Nuclear Innovation North America (NINA), has long said they need both the support of a U.S. Energy Department loan guarantee as well as aid from Japanese credit export agencies.

NRG owns 88 percent of NINA, with another Japanese company, Toshiba Corp., holding a 12 percent stake.

The municipal utility of San Antonio, Texas, owns a small stake in the reactor project but has no investment in NINA. The

Shaw Group last year inked a deal to buy a small stake in NINA, but that now looks unlikely.

NINA was also counting on investment from Tokyo Electric Power Co. (TEPCO) which owns the crippled Fukushima Daiichi nuclear power complex and is highly unlikely to invest in new nuclear overseas given its enormous financial and public relations problems at home.

TEPCO had struck a deal to buy 10 percent of NINA once the project received a DOE loan guarantee and to double that pending further milestones, but neither investment has yet been triggered.

Even while announcing it is pulling out of the STP project and NINA, NRG said Tuesday that NINA will continue to pursue an NRC license for the project as well as a DOE loan guarantee.

It is not clear how the project can advance, however, with such a dominant partner having withdrawn and with the continued commitment of remaining project partners decidedly uncertain.

NRG said "TANE will be responsible for funding ongoing costs to continue the licensing process," but said NRG will leave a one-time contribution of up to \$20 million with NINA on the way out of the project to support ongoing staffing.

In all, NRG said it will book a pretax charge of approximately \$481 million, "for the impairment of all of the net assets" of NINA.

Vancouver-based IBC Advanced Alloys Corp. announced last week it has signed collaborative research agreements with Purdue University and Texas A&M University to further develop an advanced beryllium oxide nuclear fuel the company says is safer and more efficient than existing nuclear fuels.

Nearly all commercial nuclear plants use uranium-based nuclear fuel, although

there long has been industry interest in developing thorium-based fuel, which experts say poses a smaller proliferation risk than uranium fuel.

In an April 12 press release, IBC said the new research agreements would provide for "mechanistic modeling, normal and transient modeling with Nuclear Regulatory Commission thermal-hydraulics, fuel performance and severe accident codes and experimental validation of thermal models."

The ongoing nuclear crisis at Japan's Fukushima Daiichi plant has increased interest in developing different types of nuclear fuel, as much of the radiation release has come from hot spent fuel rods in the plant's core and from spent fuel in wet fuel pools.

"The events in Japan graphically illustrate why IBC remains committed to nuclear technology and to supporting efforts to improve the safety and efficiency of the nuclear industry," said Jim Malone, IBC's vice president of nuclear fuel.

are designed to provide generators money to build new plants years before they are needed, have failed to produce new generation in New Jersey. Partly for that reason, New Jersey utilities pay far higher capacity prices than do utilities in other parts of PJM.

To encourage new in-state power plant construction, the law provides relatively high, fixed capacity payments of \$233 per megawatt-day for up to 2,000 megawatts of new generation selected by the New Jersey Board of Public Utilities (BPU).

It also requires the selected generators to bid zero into PJM capacity markets which, under existing PJM rules, ensures their capacity would not be purchased in the auction, leaving the generators free to serve New Jersey customers exclusively.

But PJM and many generators say that would artificially pull down capacity prices, discourage new plant construction across the mid-Atlantic and cost generators more than \$2 billion annually in capacity revenue.

To a lesser degree, PJM and merchant generators also are concerned about a January proposal from the Maryland Public Service Commission that would direct the state's utilities to build up to 1,800 megawatts of regulated generation or buy the same amount of power from competitive generators under long-term contracts. As in New Jersey, Maryland officials say they are frustrated that PJM capacity markets have not solved their state's power supply problems.

PJM's rule changes approved last week would block New Jersey generators from bidding zero by making them subject to a "minimum price offer" required of most generators in PJM capacity auctions.

PJM's existing policy says generators may be exempted from minimum price offer requirements if the generators are seeking to comply with state requirements designed to achieve specific policy goals.

FERC ended that waiver in last week's order, saying "the mounting evidence of risk from what was previously only a theoretical weakness in the [minimum price offer] rules that could allow uneconomic entry has caused us to reexamine our acceptance of the existing state exemption....

"For these reasons, we accept as just and reasonable PJM's proposal to eliminate the current state exemption," FERC said.

The minimum price offer requirement bars generators from offering power into capacity auctions at rates below 90 percent of the so-called "cost of new-entry," or the cost of building a new power plant. Not surprisingly, New Jersey officials tore into FERC's ruling last week, pledging to pursue all options to spur the construction of new in-state generation.

BPU President Lee Solomon said FERC's ruling "does not address the failure of the PJM market to deliver new capacity which is desperately needed to reduce New Jersey's energy prices....

"There are other options available to us that are outside of FERC's jurisdiction," Solomon continued in an April 13 press release.

"At this time, it appears that we will be forced to pursue those options."

New Jersey officials have not ruled out challenging FERC's action in court, but Solomon also appears to be referring to a more conciliatory stakeholder process aimed at spurring instate plant construction that the BPU has been directing for several months.

In December, when the New Jersey legislature was considering the legislation that ultimately became the new generation incentives statute—Solomon said the BPU would continue to hold technical conferences and stakeholder meetings in hopes "of addressing the need for new base load and mid-merit generation, and plans to continue with its efforts regardless of the outcome of pending state legislation."

FERC's order last week has drawn a more complicated reaction from the merchant generator community, which is split on the New Jersey law.

Most mid-Atlantic generators bitterly oppose the new law, with P3—a coalition that represents them—the most vocal critic.

However, the law could also be very lucrative for those few generators chosen by the BPU to receive its special treatment.

Last month, the BPU selected three such projects which would provide a total of about 1,950 MW of capacity.

They are a 625 MW combined-cycle gas plant proposed by Hess Corp. in Newark; a 660 MW gas unit proposed by NRG Energy Inc. in Old Bridge; and a 663 MW unit proposed in Woodbridge by Competitive Power Ventures.

A spokesman for Princeton-based NRG said the company is still assessing the impact of FERC's order, saying it was "continuing to move forward with the development" of NRG's Old Bridge plant, which is scheduled to come on-line in 2016.

CHP systems typically are much more energy efficient than traditional fossil-fueled sources. A gas-fired CHP, the report said, is more than 20 percent more efficient than the average gas-fired generator, and nearly twice as efficient as the average coal-fired power plant.

The CHP industry experienced strong growth between 1995 and 2002, due to strong policy drivers put in place by the Public Utility Commission of Texas (PUCT), the birth of wholesale electric competition in the 1990s, and the state's full restructuring of the electric utility industry in 2009.

NY AG Threatens To Sue Feds Over 'Fracking'

Saying the federally chartered panel has been too lax on the hot-button issue, New York Attorney General Eric Schneiderman Monday pledged to sue the Obama administration unless it agreed to commit within 30 days to conduct a full environmental review of rules proposed by the Delaware River Basin Commission that would allow for natural gas drilling in the drainage basin of the Delaware River and the New York City watershed.

Schneiderman's pledge to sue the administration, included in a letter to

four federal agencies that provide policy input to the Delaware River Basin Commission (DRBC), comes as New York oil and gas regulators have halted new drilling activity to allow more time to review the potential ecological and human health impacts of hydraulic fracturing.

The DRBC, alarmed by growing water use associated with the natural gas boom in the Marcellus Shale, in May 2009 notified drillers they must obtain an approved water management plan from the panel before beginning a gas extraction project within the basin's drainage area. The panel—consisting of governors from four northeastern states and the North American commander of the U.S. Army Corp. of Engineers—in December proposed regulations allowing for gas drilling in some cases.

In his letter, Schneiderman (D) urged the commission to immediately suspend consideration of its proposed rules and conduct a complete review of all health and safety risks associated with gas drilling in the basin under the National Environmental Policy Act.

growth in CHP adoption in the state has leveled off due to financial instability, volatile fuel prices and regulatory uncertainty, the report said. Even so, "substantial opportunity exists to implement additional CHP in Texas," it said.

Texas boasts about 17,000 megawatts of CHP today, but a 2007 PUCT report estimated that adding an additional 13,400 MW of CHP capacity by 2023 was economically feasible.

The GCCEAC, created by DOE to promote clean energy technology through the use of CHP, waste heat recovery and district energy in Texas, Louisiana, and Oklahoma, said the trend in new CHP deployment is toward smaller systems that better match the thermal requirements of smaller industrial, commercial and institutional sites. Implementation of substantial amounts of new CHP capacity "will likely require consideration of a wider range of industrial host sites, and more focus on commercial and institutional sites," the report said.

While some CHP units in Texas operate with reciprocating engines, fuel cells or a boiler-turbine configuration and use industrial waste gases, waste heat, petroleum coke and even coal, natural gas remains the predominant fuel for CHP and is expected to remain the fuel of choice for new CHP in the state. Of the nearly 17,000 MW of CHP currently operating in Texas, nearly 16,500 MW use natural gas, with more than 12,000 MW using combined cycle gas turbines.

The report modeled two business cases—a business-asusual (BAU) case and one in which state policy is designed to push development of gas-fired CHP to enable 35 percent of Texas electricity to be generated by CHP units. Achieving that goal would make CHP the largest producer of electricity among all technologies currently in use, including coal, non-CHP gas, and nuclear.

Under the grow-CHP policy, total capacity would rise from 16,900 MW to 31,000 MW—an amount larger than but within range of the 2007 PUCT estimate—and lead to an increase in electricity production from the current 80,000 megawatt-hours

(mwh) to nearly 17,500 mwh.

"This will require a large number of additional host sites and a significant investment in new facilities, possibly including expansion of CHP beyond the traditional industrial location at large refining and chemical sites to smaller process and manufacturing plants as well as commercial and institutional applications," the report said.

"Many of the smaller projects would be under the 1 MW threshold, including potential projects at nursing homes, condominiums, high schools and similar facilities that may be in the 100-1,000 kilowatt range."

Meeting the 35 percent target would increase natural gas consumption from power production in Texas from about 1,500 billion cubic feet (bcf) today to about 2,250 bcf by 2025. Compared to the BAU case, the 35 percent CHP case would increase gas consumption by about 3.3 trillion cubic feet between 2012-2025, nearly all of which would arise from additional gas used by CHP projects.

At the current price of about \$4.25 per million cubic feet, the value of this increase in gas use would be about \$14 billion, some \$2.3 billion more than projected in the BAU case.

Achieving the 35 percent target would trim annual emissions of carbon dioxide, the main greenhouse gas, from power production from 300 million tons to 250 million tons. In the BAU case, CO2 emissions increase by 12 percent by 2025. By 2025, annual CO2 emissions would be trimmed by about 81 million tons, an amount equivalent to the annual CO2 emissions of about 13.5 million cars, the report said.

Achieving the 35 percent goal would trim sulfur dioxide emissions from Texas generators by some 54 percent; in 2025, annual emissions would be reduced relative to the BAU case by about 384,000 tons, equivalent to the emissions reduction that would be achieved by retiring twenty-one 500 MW coal-fired power plants. Achieving the 35 percent goal also would result in similarly impressive reductions of nitrogen oxides.

U.S. Greenhouse Gas Emissions Fell 6.1 Percent In 2009—EPA

Total U.S. greenhouse gas emissions in 2009 fell by 6.1 percent compared to 2008, the Environmental Protection Agency announced Monday in the 16th annual U.S. greenhouse gas inventory.

EPA said emissions fell in 2009 primarily due to the economic slowdown, which cut energy consumption throughout the U.S. economy, and a reduction in the carbon intensity of electricity generation as coal prices rose and natural gas prices fell sharply.

Total emissions in 2009 of the six main greenhouse gases-carbon dioxide, methane, nitrous oxide, hydrofluorocarbons, perfluorocarbons and sulfur hexafluoride-were 6.633 billion metric tons. Total U.S. emissions have increased by 7.3 percent from 1990 to 2009, EPA said.

year to indicate a change of heart.

"This is not what we signed up for in 2002," said Richard Smith, president of Entergy's wholesale commodities business in a press conference call Monday.

Smith said the 2006 law took the decision away from an "expert decision maker, independent of legislative control," and instead put it in the hands of politicians who could shut the plant down "for unsupported or arbitrary reasons."

Led by Gov. Peter Shumlin (D), Vermont officials want to close Vermont Yankee because of a string of operation problems in recent years, although none that NRC has deemed a safety threat.

Vermont officials also believe that Entergy officials misled a state panel in 2009 over the potential for the plant to leak tritium, less than a year before a large tritium leak was discovered at the Vernon, Vt., plant site.

Entergy's lawsuit was not unexpected, and has appeared more likely in recent weeks as Entergy admitted failure in an attempt to sell Vermont Yankee and failed to ink new power supply deals with the state's utilities.

The suit comes three weeks after the Nuclear Regulatory Commission extended the plant's operating license by 20 years, allowing Entergy to argue that the agency with sole jurisdiction of U.S. nuclear plant safety and public health has judged continued operation of Vermont Yankee to be safe.

While the NRC jurisdictional issue was widely expected to go to court, Entergy also accused Vermont officials Monday of trying to extract below-market power rates for state utilities as a condition for keeping Vermont Yankee running, which the utility said violated Federal Energy Regulatory Commission jurisdiction over wholesale power markets.

A spokeswoman for Shumlin was not immediately available for comment on the allegation Monday, nor were officials with Vermont's Department of Public Service, the agency that will take a primary legal role in battling Entergy's suit.

The suit is likely to determine the fate of one of New England's largest generators, which produces fully one third of Vermont's power.

In a release announcing the legal action, Entergy suggested it went to court only as a last resort.

"Despite the fact that Vermont Yankee is important to the reliability of the New England electric transmission grid, emits virtually no greenhouse gases, and provides more than \$100 million in annual economic benefits to the state of Vermont, it has been made clear that state officials are singularly focused on shutting down the plant," said Smith in the release.

"That has left us with no other choice but to seek relief in the court system," he said. Smith told reporters Monday that

last year to shut the plant and lawmakers have said little this he met personally with Shumlin March 31 to appeal for continued operation of the plant, but said Shumlin reiterated strong opposition.

> Legal experts say Vermont's efforts to close the plant will likely hinge on officials' ability to demonstrate they are closing the plant for reasons other than safety and public health, because those issues are clearly the subject of NRC jurisdiction exclusively.

> Instead, Vermont officials likely will argue they are closing the plant based on economic, electric system reliability or other non safety-related considerations, which experts say will be challenging given that the plant employs about 650 Vermonters and is highly beneficial to New England's grid stability.

> The region's grid operator-ISO-New England-said last year that looming reliability concerns in northern New England would be exacerbated if Vermont Yankee were closed.

> In the lawsuit, Entergy repeatedly attempts to show that Vermont's shutdown attempt is based solely on state assessments of the plant's safety and impact on public health-and thus clearly encroaches on NRC authority.

> "Vermont's certificate of public good scheme, whether administered by the PSB or the General Assembly, interferes with exclusive federal authority over the continued operation of a nuclear power plant," because it has "has been employed in a way that reveals its focus on nuclear safety concerns that are entrusted exclusively to the federal government," Entergy said.

> Additionally, Entergy claims a 1983 Supreme Court decision backs its lawsuit against Vermont. In that case, the court backed California's right to impose a moratorium on new plant construction, but only for economic reasons.

> "A state's regulation of the 'construction or operation of a nuclear power plant ... even if enacted out of non-safety concerns...directly conflict[s] with the NRC's exclusive authority over plant construction and operation," say Entergy's lawsuit, citing the case.

> Interestingly, some observers think Entergy might be suing to block Vermont's shutdown in order to publicly clear away a hurdle to selling the troublesome plant. Entergy announced efforts to sell the plant last fall, but says an "uncertain political environment" has spooked would-be buyers.

> Without Vermont Yankee, the state's utilities would be forced to find a significant amount of new power, although that task has been made easier by a recent drop in natural gas prices that has made gas-fired power more affordable than in the past.

> Perhaps to highlight the state's alternatives to Yankee, Shumlin, Central Vermont Public Service Co. and Green Mountain Power, the state's two largest utilities, released a joint statement Monday hailing recent PSB approval of 26-year deal for generator Hydro-Quebec to sell the utilities power.

In what the utility is touting as one of the world's largest battery-powered electricity storage systems, Duke Energy announced Thursday week it will store electricity produced at its 153 megawatt Notrees Windpower Project in west Texas using an energy storage and power management system developed by Austin, Texas-based Xtreme Power.

Duke in November announced plans to match a \$22 million Energy Department grant under the American Recovery and Reinvestment Act grant to install a large-scale, 36 megawatt battery system capable of storing electricity produced by the wind farm.

When completed next year, the \$44 million project will store excess wind energy and discharge it whenever demand for electricity is highest. In addition, Xtreme Power's Dynamic Power Resource will help stabilize the frequency of the electricity flowing through the grid, Duke said.

Duke Energy will work closely with

the Energy Reliability Council of Texas to integrate the wind power and battery storage solution into the state's independent power grid. The Electric Power Research Institute will advise the project team, collect data and help assess the potential for broader adoption of energy storage solutions throughout the industry. Results from the storage project will be shared publicly through the DOE's Smart Grid Information Clearinghouse.

Based in Kyle, Texas, Xtreme Power engineers, manufactures and operates large-scale digital power systems for use in renewable energy and micro-grid applications.

nents used by the companies, such as salt and citric acid, are largely benign and pose no threat to human health or the environment.

However, the report says the firms over the five-year period injected 11.4 million gallons of drilling products containing either benzene-a known carcinogen-toluene, xylene or ethylbenzene, all of which are regulated under the Safe Drinking Water Act (SDWA) for their risks to human health or listed as hazardous air pollutants under the Clean Air Act. Led by Texas, nine states had at least 100,000 gallons of fracking fluids containing a carcinogen, the report said.

The report, released by Reps. Henry Waxman (Calif.), the committee's senior Democrat, Edward Markey (Mass.), ranking Democrat on the House Natural Resources Committee and Diana DeGette (D-Colo.), also expressed alarm over the gas industry's use of methanol-a hazardous air pollutant under the Clean Air Act-in 342 hydraulic fracturing products.

The report also included findings released by the lawmakers earlier this year that some 32 million gallons of diesel fuel or diesel-infused fluids were used in hydraulic fracturing operations at oil, natural gas and coalbed methane wells in 19 states during the period—all without drillers or service firms getting required permits or conducting environmental reviews to make sure the fluids posed no threat to underground drinking water supplies.

The report says toxic diesel fuel was used in 51 different hydraulic fracturing products.

Commenting on the report's findings, Waxman in a statement urged the Energy Department and Environmental Protection Agency (EPA), currently reviewing the environmental impacts of hydraulic fracturing, to "make certain that we have strong protections in place to prevent these chemicals from entering drinking water supplies."

The drilling practice is mostly exempted from regulation by the EPA under the SDWA.

Legislation proposed by DeGette during the last Congress and reintroduced last month would reverse an exemption granted to fracking in the Energy Policy Act of 2005. DeGette's bill, dubbed the Fracturing Responsibility and Awareness of Chemicals (FRAC) Act, would require drillers that use hydraulic fracturing to disclose to the state—or to the EPA in certain cases-the fracking chemicals they use.

formulas of fracking fluids that each gas services firm uses, was previously squelched by key Democratic leaders, including Waxman, who urged DeGette to wait until EPA completes its review of fracking.

Environmentalists say that lack of knowledge about the chemicals drillers use makes it impossible to determine if hydraulic fracturing is causing any ecological or health threat.

Many states and localities, most notably New York, have held up new gas drilling to determine if tougher oversight of hydraulic fracturing is necessary.

However, the gas industry says fracking is safe and vital to the nation's shale gas boom.

Natural gas industry groups responded to the report with a collective shrug Monday, saying its findings revealed little new information. Producers groups also said the report's detailed breakdown of fracking chemicals used by drillers is redundant in light of a new industry-backed, voluntary Web-based registry that went live last week that gives drillers the opportunity to publicly disclose the chemicals they use in hydraulic fracturing.

The website, FracFocus.org, debuted April 11 and several of the largest U.S. natural gas producers, such as XTO Energy Inc., Chesapeake Energy Corp., Cabot Oil and Gas Corp., Anadarko Petroleum Corp., and others have already begun uploading information.

The registry, characterized as a proactive response to political pressure to make fracking chemical data available and as pushback against congressional efforts to "federalize" such disclosures, is a project of the Interstate Oil and Gas Compact Commission and the Ground Water Protection Council, the coalition of state groundwater regulatory agencies.

The registry is open to oil and natural gas producers to publically disclose data on the non-proprietary chemicals they use as well as when and in which state they are used.

However, the database has yet to be endorsed by the services firms that provide producers with the mix of chemicals, water and sand that producers inject underground.

DeGette said voluntary initiatives such as FracFocus.org are not enough to ensure regulators and the public that drillers are using fracking fluids safely, noting that many of the companies that provided House Democrats with fracking data were "unable to even identify some of the chemicals they were using DeGette's bill, which also would protect the proprietary in their own activities."

said construction of the 1,959-mile project would have limited adverse environmental impacts and was needed to provide "a reliable and cost-efficient source" of crude oil from a friendly ally.

However, in July 2010, Rep. Henry Waxman (D-Calif.), then-chairman of the powerful House Energy and Commerce Committee, protested the oil pipeline project, saying it would increase U.S. reliance on "the dirtiest source of transportation fuel currently available."

Waxman has also expressed concern that the State Department's draft EIS of the pipeline failed to adequately consider the project's climate change impacts. The Environmental Protection Agency echoed that sentiment in a July 16 letter to State Department officials, calling the draft EIS inadequate.

The proposed pipeline also sparked protest from Nebraska Republicans, who expressed concern that the line threatens a vital aquifer and that State's draft review of the line failed to adequately consider alternate routes.

In separate letters to Clinton, Nebraska Sen. Mike Johanns and Nebraska Gov. Dave Heineman both said errant oil spills could pollute the huge shallow underground Ogallala aquifer, referred to by Heinemann as "the lifeblood of Nebraska's agriculture industry."

However, the State Department is widely expected to approve the project—indeed State has already approved two other oil sands pipelines connecting Albertan production areas with U.S. markets, including Keystone 1, TransCanada's initial crossborder line—and the supplemental draft EIS released last Friday suggests Keystone XL remains on track.

The draft supplemental review includes new information on proposed project facilities and regulatory requirements as well as additional information on the potential impacts to groundwater from an errant oil spill—including additional data on the Ogallala aquifer.

In comments on the hydraulic conductivity of the Ogallala Formation, the State Department said "localized preferential flow paths do exist that could enable dissolved chemicals to move at an increased rate through the unsaturated zone to the water table."

However, State downplayed the import of that finding, adding that localized ash beds prevalent within the geological formation would "tend to inhibit vertical migration of dissolved contaminants.

"...even very large spills would likely be limited to localized groundwater contamination that would not threaten the regional viability of the aquifer system," said the report.

Partially on those findings, the report only considered one potential alternative route for Keystone XL that would avoid the aquifer entirely and four that would limit its exposure.

State staff said none offered an overall environmental advantage over the proposed route.

The agency also punted on the possibility that a spill might occur on Keystone XL, saying "TransCanada's limited operating history with crude oil pipelines precludes a direct comparison of accident and oil spill incident rates specific to TransCanada with the industry average rates."

In comments on the project's potential climate change impacts, the report notes the principal greenhouse gas of concern related to construction and operation of the pipeline is carbon dioxide (CO2), which enters the atmosphere through the burning of fossil fuels.

Greens have fiercely opposed the pipeline because they say it would accelerate production of Canadian oil sands, which requires significant amounts of natural gas to produce steam used to melt the oil sands *in situ* so it can be extracted. Because of the extra emissions associated with these production techniques, oil sands oil has a significantly higher carbon "footprint" than conventional oil, they say.

In addition, because developers would have a million barrels per day of new pipeline transportation capacity to move their oil to Gulf refineries if Keystone XL were approved, Canadian oil sands developers would have a clear incentive to expand production, greens assert. They also charged that State ignored emissions that would result from the construction of new facilities as developers expanded their operations.

State, however, concluded that the pipeline would not lead to a dramatic expansion of Canadian oil sands development.

In expanded comments on the project's potential "life-cycle" emissions—those arising from the extraction, refining and use of Canadian oil sands oil—the report said "it is clear that [oil sands oils], as would likely be transported through the proposed project, are on average somewhat more greenhouse gas-intensive" than the Mexican, Venezuelan and Saudi Arabian crudes they would displace in U.S. refineries.

But State said the pipeline's overall contribution to cumulative greenhouse gas impacts from the project "would not constitute a substantive contribution to the U.S. or global emissions."

However, the assessment estimated that oil sands oil's lifecycle emissions would be 17 percent higher than the average 2005 lifecycle emissions of all oils consumed in the United States.

The assessment also said that U.S. emissions would increase by as little as 3 million metric tons of carbon dioxide equivalent (MMTCO2e) per year or as much as 21 MMTCO2e annually, depending on what kinds of oils were displaced at U.S. refineries.

The report was greeted warmly by TransCanada, with its President and Chief Executive Officer Russ Girling predicting final U.S. approval of Keystone XL before the year is out.

However, environmentalists complained that the new report gave short shrift to route alternatives, climate change impacts and other key issues.

"This environmental review for the proposed Keystone XL tar sands pipeline is as inadequate as their first go-round, with the State Department merely paying lip service to critical issues such as pipeline safety, the routing over the Ogallala Aquifer, and environmental justice around refineries," said Susan Casey-Lefkowitz, international program director for the Natural Resources Defense Council, in an April 15 statement.

determining the level of a NAAQS.

The policy assessment is an important step in moving toward a new NAAQS, and is meant to bridge the gap between the relevant scientific evidence and technical information and the judgments required of the EPA administrator in determining whether, and if so how, to revise the NAAQS.

Fine particulate matter is defined by the agency as being 2.5 micrometers in diameter and smaller (PM2.5). These particles can be directly emitted from sources such as forest fires, or can form when gases emitted from power plants, factories and automobiles react in the air.

PM2.5 is particularly harmful to human health because they can lodge deep within lung tissue, causing inflammation and exacerbating existing respiratory ailments. EPA says fine particle pollution is responsible for thousands of premature deaths every year, tens of thousands of non-fatal heart attacks, and similarly large volumes of asthma attacks, particularly in children.

In their primary recommendation for a new standard, EPA staff said the existing annual standard—measured in micrograms per cubic meter—should be revised downward, while the current 24-hour standard could remain unchanged.

"Taking into account both evidence-based and risk-based considerations, staff concludes that consideration should be given to revising the current annual PM2.5 standard level of 15 micrograms per cubic meter to a level within the range of 13 to 11 micrograms per cubic meter," the staff said. "Staff further concludes that the evidence most strongly supports consideration of an alternative annual standard in the range of 12 to 11 micrograms per cubic meter.

The staff also said that "in conjunction with consideration of an annual standard level in the range of 12 to 11 micrograms per cubic meter, staff concludes it is appropriate to consider retaining the current 24-hour PM2.5 standard level at 35 micrograms per cubic meter. In conjunction with consideration of an annual standard level of 13 micrograms per cubic meter, staff concludes there is limited support to consider revising the 24-hour PM2.5 standard to somewhat below 35 micrograms per cubic meter, such as down to 30 micrograms per cubic meter."

The recommendation is not likely to sit well with the utility industry, which already is waging an aggressive lobbying campaign against EPA proposals to establish a "maximum achievable control technology" standard for hazardous air pollutants; to finalize a regional program to reduce transported air pollution in 30 eastern states; to limit greenhouse gas emissions; and to require changes in the way power plants use water to cool steam, among other initiatives.

EPA's most recent action on the PM2.5 NAAQS came in 2006, when the agency under the George W. Bush administration opted to retain the annual standard of 15 micrograms per cubic meter set in 1997 during the Clinton administration. EPA did choose to tighten the 24-hour standard from 65 micrograms per cubic meter to 35 micrograms per cubic meter.

In that rulemaking, EPA for the first time in its history rejected recommendations from an advisory panel of scientists the Clean Air Science Advisory Committee (CASAC)—that the agency tighten both the annual and 24-hour standards.

In 2005, when EPA—then led by former Administrator Stephen Johnson—proposed to tighten only the daily standard, CASAC two months later took the highly unusual step of holding a public teleconference to consider whether to provide the agency with "further advice and recommendations" on the fine particle limits. In March 2006, CASAC members sent a letter to Johnson urging him to reconsider the proposed rule and to accept their recommendations to tighten both the daily and annual standards, saying they had "serious scientific concerns" with Johnson's proposal to tighten only the daily standard.

When the final NAAQS was published in 2006, three environmental and public health organizations sued the agency over the regulation. In 2009, the U.S. Court of Appeals for the District of Columbia Circuit declined to vacate the standards, saying doing so would sacrifice the health improvements likely to ensue from allowing the revised daily standard to remain in place.

But the court said EPA failed to adequately explain its decision to leave the annual standard unchanged, giving current EPA Administrator Lisa Jackson an opportunity to revise the annual standard if she determined it necessary.

While CASAC has yet to weigh in on the EPA staff's final policy recommendation, the panel in September sent a letter to Jackson in support of the staff's recommendations in a draft policy assessment.

"CASAC supports the EPA staff's conclusion in the Second Draft Policy Assessment" that 'currently available information clearly calls into question the adequacy of the current standards."

DOE's conditional loan guarantee will back two units at the plant, with an initial combined capacity of 484 megawatts; the project is designed for expansion to 1,000 MW eventually.

DOE says all of the output from the plant is contracted for sale to Southern California Edison, a key financial underpinning.

The Blythe project will be the first U.S. concentrating solar power (CSP) parabolic trough plant to use an air-cooled condenser unit, which will decrease water use by nearly 90 percent compared with a water-cooled CSP facility—a key benefit in the dry Southwest.

holders, the Federal Energy Regulatory Commission, the Public Utilities Commission of Ohio (PUCO) and the Department of Justice, which will look into anti-trust concerns.

Given that AES has virtually no assets in Ohio, it is unlikely that any of those reviews will turn up any significant market concentration concerns.

However, the PUCO may give the deal a close look from a financial and ratepayer perspective given that it will be financed largely with debt, namely a bridge loan from Bank of America Merrill Lynch.

The DPL buy clearly highlights a corporate strategy shift underway at AES, which for years focused on expanding aggressively overseas and bulking up on merchant generation.

By contrast, the company is now focused on acquiring relatively conservative U.S. electric utilities, AES President and Chief Executive Officer Paul Hanrahan said Wednesday, to build on its 2000 acquisition of Indiana-based IPL, the parent of Indiana Power & Light Co.

"We are concentrating our growth efforts in a few key markets, including the U.S. utility sector, where we see ways to leverage our global platform of 40,500 [megawatts of generation capacity] and 11.5 million utility customers," said Hanrahan in a press release announcing the DPL buy.

In particular, the DPL buy will "build on our nearby utility business at Indianapolis Power & Light Company," he said.

Among other benefits, acquisitions like DPL substantially cut the risk of AES' largely international portfolio and could in the long-term boost its current credit ratings, which are below investment grade.

Credit agencies favor the regulated returns that utilities provide, although AES officials acknowledged the company's credit rating could take a short-term hit because the DPL buy will be financed largely with debt.

However, Moody's Investors Services praised the deal Wednesday while maintaining its "B1" rating on AES and changing its outlook from neutral to positive.

Moody's Vice President Scott Solomon said the new outlook is "supported by the sound rationale for the proposed acquisition which, if consummated, would reduce AES' business risk profile and help to improve financial performance from current levels."

DPL's primary asset—Dayton Power & Light—serves more than 500,000 retail customers in west-central Ohio.

Other subsidiaries are DPL Energy, a merchant generator with mostly peaking facilities; and DPL Energy Resources, a competitive electric supplier serving Ohio industrial and commercial customers. With the acquisition, AES will add approximately 3,800 megawatts of generation capacity in Ohio, including 2,800 coalfired megawatts and 1,000 megawatts of natural gas and diesel peaking units.

Globally, AES runs 14 utilities and controls 40,300 megawatts of generation. The company's far-flung operations are in Chile, Cameroon, China, Bulgaria and 25 other countries, with a particular concentration in Latin America and Europe.

One of the liabilities of the DPL purchase initially would appear be the coal-heavy nature of the generation fleet AES is acquiring, given the likelihood that coming EPA air quality regulations, combined with low natural gas prices, will force the retirement of many U.S. coal plants, particularly smaller and older units.

But AES officials said in a Wednesday conference call with analysts that DPL's coal fleet is actually positioned to cash in on that possibility.

AES Executive Vice President and President of North America and Global Wind Generation Ned Hall said AES expects 20 percent of the coal fleet in the region's power market—run by PJM Interconnection LLC—to retire in the next few years. However, DPL's units are clean enough that most will not be retired, and will instead cash in on capacity prices that will rise as other units retire and the region's supply portfolio shrinks, Hall said.

For example, Hall said 85 percent of DPL's coal units already are equipped with selective catalytic reduction for nitrogen oxides, as well as sulfur dioxide scrubbers—pollution controls that virtually all coal-fired power plants will have to install if the EPA rules are finalized. By contrast, Hall said only 45 percent of PJM's overall coal fleet is fitted with these control technologies.

Hall also acknowledged that AES is watching closely the somewhat unusual rate-setting process in Ohio to which Dayton Power & Light is subject, under which regulated utilities can either negotiate regulated "electric security plans (ESP)" with the PUCO or seek approval for a market-based rate plan.

The process has been rocky at times; no Ohio utilities have won approval for market rate plans, and ESP plans have in some cases been contentious and slow to be approved.

On Tuesday, the Ohio Supreme Court ruled that the PUCO unlawfully approved \$63 million in rate recovery under an ESP for Columbus-based American Electric Power Co., partially backing complaints from Ohio's Office of Consumers' Counsel and industrial customers.

DPL is set to re-negotiate its rates with PUCO next March.

Investors appeared to like the deal for DPL, sending AES shares up more than 3 percent Wednesday to close at \$12.88 per share.

Negotiations Begin on Targeted Cut Level

MORNING BRIEFING

Detailed negotiations on a tentative agreement on spending cuts began Wednesday, in a major step that could prevent a government shutdown at the end of next week.

Democrats and Republicans are targeting about \$33 billion in cuts for the current fiscal year, although that number could change, Vice President Joseph R. Biden Jr. told reporters. Biden, visiting Senate Democratic leaders to make sure they were all on the same page, said House Speaker John A. Boehner, R-Ohio, had agreed to begin negotiations at that level of cuts, which Biden described as \$73 billion below the president's fiscal 2011 request, versus the \$100 billion cut Republicans were seeking. But, Biden cautioned, "I spoke to John. John makes it clear. It's the same as our position. There is no deal until there's a total deal, okay." Biden said that much will depend upon the composition of the cuts, and suggested that cuts to Defense and mandatory spending could be included. "Democrats are in full agreement on what we don't want to do in that number. We don't want to eviscerate the ability of the economy to grow," the vice president said.

Negotiations will also be occurring on the possible inclusion of policy provisions, or riders, that the House passed as part of its spending cut bill (HR 1) in February. "The president and I are not really big on any riders at all. But this is a process which is normal for the House and Senate Appropriations Committees to get into the details," Biden said, adding, "We've made it clear what we think are non-starters, both in numbers and riders." Republicans included dozens of policy provisions in <u>HR 1</u> that prohibit federal spending for specified activities, including controversial provisions to ban funding for Planned Parenthood, implementation of the health care overhaul law, and EPA regulation of greenhouse gas emissions. House and Senate appropriators, who are now negotiating the spending details, might consider some policy provisions, but the more controversial riders will be negotiated by leadership, an aide said. Questions regarding riders may be the toughest negotiations of all, Biden indicated. Boehner will be facing pressure from GOP conservatives, who want the full \$61.5 billion in spending cuts included in <u>HR 1</u>, as well as the policy riders Democrats most oppose — those dealing with Planned Parenthood and the health care law. At the targeted level of \$33 billion in cuts for negotiations, Republicans would be backing off from almost \$29 billion in cuts they had previously passed, while Democrats would be supporting an additional \$23 billion in cuts beyond the \$10 billion that had been enacted as part of the last two CR extensions. Many GOP freshmen and conservatives yesterday called for enactment of the full \$61.5 billion in cuts, arguing that for negotiations to occur Senate Democrats need to first pass their own spending cut bill. Tea party groups will be rallying at the Capitol on Thursday urging GOP lawmakers to stick to their campaign promises to make deep, immediate cuts in spending.

House GOP leaders will give their members another chance on Friday to vote for the full \$61.5 billion in cuts, in what will be a strictly symbolic vote. Majority Leader Eric Cantor, R-Va., said that in response to the Senate's failure to act, the House will consider a measure intended to force its hand. The bill provides that <u>HR 1</u> would become law if the Senate fails to pass legislation to fund the government for the remainder of the fiscal year, and it would prevent lawmakers and the president from being paid for the duration of any government shutdown lasting more than 24 hours. Although the Democratic Senate is certain to ignore the measure, Cantor said the "Government Shutdown Prevention Act" will send a message. It "will say to the American people, the Senate has to act prior to the expiration of the CR. If it does not act, <u>HR 1</u> becomes the law of the land. And if there is a partial shutdown, members will not get paid. Simple as that," Cantor said. "We're serious and we want to take care of this problem, so that we can get on about the business of this nation and get Americans back to work." Cantor Statement

SENATE BUDGET SET TO VOTE ON OMB NOMINEE: The Senate Budget Committee on Thursday is scheduled to vote on the nomination of Heather A. Higginbottom to be Deputy Director of OMB.

Higginbottom's nomination is expected to be approved by the panel, although she will likely receive some Republican opposition. During her

confirmation hearing March 17, top Budget Republican Jeff Sessions of Alabama, questioned whether she had the experience for the position, saying that most persons who held that post had six or seven years of professional experience in budget and finance. Higginbottom is a past legislative director for Sen. John Kerry, D-Mass., worked on two presidential campaigns managing policy, and has worked in the White House on the Domestic Policy Council. Sessions has criticized President Obama's fiscal 2012 budget for failing to address growing debt and deficits and argued that the administration has misrepresented what its budget would do. "I cannot support a nominee for this position, especially at such a time like this, who is unable to discuss the budget with clarity and candor," Sessions said at the beginning of the hearing. Sessions subsequently had some testy exchanges with Higginbottom during the hearing. Senate Budget Chairman Kent Conrad, D-N.D., expressed support for Higginbottom's nomination, noting that OMB Director Jacob J. Lew selected her and wanted her in that post, and that former deputy directors had similar backgrounds to Higginbottom's.

BLUE DOG BENCHMARKS DRAW ACCOLADES: Budget watchdog groups on Wednesday applauded the House Democratic Blue Dog Coalition for releasing a concrete set of goals for reducing deficits and stabilizing the national debt. **"This framework is about putting everything on the table and bringing both parties together for a frank conversation about how we forge a fiscally responsible and sustainable path forward," said Kurt Schrader, D-Ore.,** chairman of the Blue Dog Task Force on Fiscal Responsibility. Blue Dog co-chairman Mike Ross, D-Ark., said, "The Blue Dogs are inviting everyone to the table because until we start having a grown-up conversation, we will continue to mortgage our future on the backs of our children." The group of fiscally conservative Democrats recommends striving for \$4 trillion in deficit reduction over the next 10 years, with discretionary spending returning to 2008 levels by 2013 and the "largest deficit cuts in history" by 2014 so that the deficit shrinks to 2.3 percent of GDP in four years. Debt as a share of the economy should be reduced and stabilized at 60 percent of GDP by 2024, they recommend, with the size of the government being reduced. The Blue Dogs don't recommend any specific policy proposals, but say everything must be on the table – including defense and non-defense cuts in discretionary spending, changes to major entitlements and other mandatory programs, changes to the tax code, and budget process reforms — with deficit reduction coming from both spending cuts (two-thirds of the savings) and tax "reform" (one-third). <u>Blue Dog Release</u>

"With their leadership on this issue, the prospects for reform surely became a great deal brighter," said fiscal commission co-chairmen Erskine Bowles and Alan K. Simpson, who noted that the Blue Dogs "have a long history of building coalitions across party lines and being at the center of significant bipartisan reforms." They added, "Whatever a final plan may look like, it is our belief that if it follows the principles of reform laid out today by the Blue Dogs, it will be of the scope and magnitude necessary to meaningfully address our nation's fiscal challenges." Other anti-deficit organizations concurred, highlighting the need for deficit reduction efforts to be considered on a comprehensive, bipartisan basis, and also pointing out recent calls from prominent groups – including the group of 64 bipartisan senators and 10 former chairmen of the president's Council of Economic Advisers - that the president and lawmakers need to begin serious discussions on the issue. "The Blue Dogs have added their voice to a growing chorus of leaders and experts from both sides of the aisle who are ready to come together to solve this problem," said Maya MacGuineas, president of the Committee for a Responsible Federal Budget. "The President and congressional leadership should heed the call."

HOUSE APPROPRIATORS SPAR OVER USAID FUNDING: The head of the U.S. Agency for International Development (USAID) on Wednesday defended the Obama administration's fiscal 2012 budget request before a House Appropriations panel, amid concerns from Democrats about proposed GOP spending cuts.

House State-Foreign Operations Subcommittee Chairwoman Kay Granger, R-Texas, said that while she "understands the value of many of these important programs, the funding request for the next year is unrealistic in today's budget environment." Granger said the administration's fiscal 2012 proposal includes \$59.5 billion for the annual State-Foreign Operations bill, \$10.7 billion (22 percent) above nonsupplemental fiscal 2010 funding. (The administration and international aid

community consider 2010 supplemental funding to be base funding going forward, and therefore don't consider the 2012 request to be such a large increase.) Granger stressed that she does believe "a large portion of the USAID request directly supports our national security." But she added, "We must focus on slowing the rapid growth of some programs, eliminating duplicative programs and personnel, and increasing oversight and transparency." In February, Secretary of State Hillary Rodham Clinton wrote to House Appropriations Chairman Harold Rogers, R-Ky., expressing concern that the fiscal 2011 spending bill (<u>HR 1</u>) represented a 16 percent cut to funds for foreign aid and State compared with fiscal 2010 funding levels. Clinton said the cuts "will be devastating to our national security."

Granger Opening Statement

USAID Administrator Rajiv Shah emphasized the agency's work to increase accountability and measure results in order to "get more leverage and better results for American taxpayers." Shah told appropriators it is "crucial" for Congress to fully fund USAID's fiscal 2012 operational budget request of \$1.5 billion, an 8 percent boost over fiscal 2010 levels, in order to support the agency's ongoing efforts to overhaul procurement and contracting practices and to tighten oversight. The administration's request includes funds for a staffing surge and leadership initiative aimed at filling gaps in priority countries and frontline states. Granger questioned the call for more employees, asking whether "this global staffing surge should remain a priority" given that the nation is "facing such a dire fiscal situation." Shah said the agency had seen a 57 percent reduction in staffing over several decades while its programmatic responsibilities had increased. In an effort to overhaul its operating model, Shah said the agency is requesting more technical officers and procurement and contract specialists whose work will help save taxpayer dollars.

Shah Prepared Testimony

Shah joined panel Democrats in expressing concern about cuts to international development programs included in the House GOP

spending bill. Nita M. Lowey of New York, the panel's top Democrat, said the cuts "will imperil the agency's efforts to regain the expertise to be the premier development agency in the world." Jesse L. Jackson, Jr., D-Ill., asked Shah to explain the effect of a proposed 50 percent cut to the International Disaster Assistance account. Shah said the cut would be "the most dramatic backing away from our responsibilities around the world in decades." He cited specific countries in which such a decrease in funds would create a large impact, including the Darfur region of Sudan, where 1.6 million people are currently

receiving aid and 800,000 people could be put at risk. In some cases, Shah said, the United States "would simply not be able to respond to disasters." Shah expressed a willingness to look for budget savings, but emphasized his belief that "there is a way to do this that does not cost lives" by "being more businesslike in how we do our work, reining in contract partners, and doing better program oversight."

Lowey Opening Statement

Panel members of both parties voiced concern about the agency's efforts to build institutional capacity and safeguard USAID funds against corruption in countries like Afghanistan and Pakistan. USAID has set a goal of reaching 20 percent direct assistance in many countries by 2015, and 50 percent direct assistance in Afghanistan and Pakistan. In response to questions from both Granger and Lowey regarding those countries' ability to handle direct assistance, Shah said USAID's procurement overhaul is designed to allow the agency to work with a broader range of partners and deliver development assistance "without losing as much to middle institutions along the way." He emphasized the goal of holding USAID's local partners accountable, adding that the agency is "able to monitor the flow of resources using the same process we would use with any other independent contract partner." He also stressed the importance of building capacity "so that we have an exit strategy over time and we can step away from our assistance."
