Dear Mr. Davis:

This letter documents that on September 11, 2012, and January 17, 2013, Randolph Ragland of the NRC Region I office conducted a security inspection at your Rocky Mount facility, and on December 3, 2012, Geoffrey Warren of the NRC Region III office conducted an inspection at your Hospira Global Security office in Lake Forest, Illinois. The inspection at the Rocky Mount facility was observed by Grant Mills from the State of North Carolina, Division of Environmental Health, Radiation Protection Section. During this inspection, one or more security violation(s) was/were identified. Hospira Inc. took immediate corrective actions to address any security related vulnerabilities. The results of that inspection were included in a report that was forwarded to you by letter dated February 12, 2013.
