Ansys Software Licenses

On February 1, 2013, a firm-fixed-price contract (GS-35F-0639N/NRC-HQ-13-P-04-0053) was awarded to Ansys, Inc., of Canonsburg, PA, for Ansys software licenses and related maintenance. The period of performance is February 1, 2013, to January 21, 2014, with two 1-year options. The total estimated cost is \$455,012.82, inclusive of options.

Spent Fuel Cask Certificate of Compliance Format and Content; Petition for Rulemaking; Receipt and Request for Comment; 10 CFR Part 72 (PRM-72-7; NRC-2012-0266)

On February 5, 2013, the NRC published a notice of receipt and request for comment for a petition for rulemaking (PRM) in the *Federal Register* (78 FR 8050). The PRM was filed by Anthony Pietrangelo (the petitioner) on behalf of the Nuclear Energy Institute on October 3, 2012. The PRM was docketed by the NRC on October 18, 2012, and assigned Docket No. PRM-72-7. The petitioner requests that the NRC add a new rule that governs the format and content of spent fuel storage cask Certificates of Compliance (CoC), extend the backfit rule to CoCs, and make other improvements that result in “more efficient and effective NRC oversight of dry cask storage activities as well as improved implementation of dry cask storage requirements by industry.” Public comments are due by April 22, 2013.

Addition of South Sudan to the Restricted Destinations List; Final Rule; 10 CFR Part 110 (RIN 3150-AJ21; NRC-2012-0278)

On February 6, 2013, the NRC published a final rule in the *Federal Register* (78 FR 8360) amending its export and import regulations by adding South Sudan to the list of restricted destinations. The amendment was necessary to conform the NRC regulations to U.S. Government foreign policy. The final rule was effective on February 6, 2013.

Revised Schedule Issued for Levi Combined License Application

On January 24, 2013, the staff issued a letter to Progress Energy Florida that revised the schedule for issuing the final safety evaluation report for the Levy Units 1 and 2 combined license application. The revised issuance date of September 2013 is based on the applicant providing timely and complete information to support the staff's review in several areas where applicant submittals are pending.

Preliminary Amendment Request for Vogtle Units 3 and 4 and Summer Units 2 and 3

On January 29, 2013, NRC sent letters to Southern Nuclear Operating Company (SNC), Inc. and South Carolina Electric and Gas Company (SCE&G) (the licensees for Vogtle Units 3 and 4, and Summer Unit 2 and 3, respectively) that reflected "no objection" to the licensees proceeding with the installation of the proposed plant changes identified in the Preliminary Amendment Requests (PARs) dated January 22 and 24, 2013. The PARs were limited to installation, testing, and quality control activities associated with the nuclear island basemat structure. SNC and SCE&G acknowledged in their requests that they will not pour the nuclear island basemat concrete until they each receive NRC approval of the related license amendments submitted earlier.

Grand Gulf Nuclear Station, Unit 1 License Renewal Safety Evaluation Report with Open Items

On January 31, 2013, the staff issued the Safety Evaluation Report (SER) with Open Items related to the Grand Gulf Nuclear Station, Unit 1 license renewal application. By letter dated October 28, 2011, Entergy Operations Inc., submitted an application requesting the extension of the Station's operating license for an additional 20 years. The SER contains four open items related to: (a) the evaluation of operating experience to ensure that the One-Time Inspection – Small-Bore Piping Program will adequately manage the effects of aging American Society of Mechanical Engineers Code Class 1 small-bore piping, (b) the management of material due to erosion by the Service Water Integrity Program, (c) the evaluation of future operating experience to ensure that the aging management programs will remain effective for managing the effects of aging during the period of extended operation, and (d) the calculation methods used in the neutron fluence analysis.
