Below is a link to a map that will help you in locating the plant and the hearing location. I have also attached an updated agenda.

When you pull up to the guard shack, please pull into the center line, exit the cars and go into the shack. We will have a project person there to greet you. They will check ID's and give you a map to the location of the meetings. You should check in with the guards around 7:15 to 7:30.

We will meet at 7:30 in the Conference room of the 13 Wide trailer. Directions will be on the map you are provided at the guard shack.

It is scheduled to be in the low to mid 40's all week. You will need a jacket and possibly gloves and a hat.

You are not required to wear hard toed shoes, but please wear them if you have them. Steel toed shoes will need to be removed and run through the x-ray machine for those entering the ISFSI.

Please ask those attending to wear comfortable cotton clothing. Jeans are acceptable. The technical review team entering the ISFSI should avoid wearing polyester or fleece – have them try and stick to cotton clothing.
