By letter dated August 29, 2012 (Agencywide Documents Access and Management System [ADAMS] Accession No. ML12243A245), FirstEnergy Nuclear Operating Company (FENOC) submitted notification of a change in a regulatory commitment regarding the submittal of an application for license amendment to implement 10 CFR 50.48(c) at Beaver Valley Power Station, Units No. 1 and 2, by transitioning to National Fire Protection Association Standard 805.
