2) Physical Description

This shipment will consist of 480 drums of Uranium Ore Concentrate (U-308) in 10 x 20' ocean containers. The total weight of the shipment is 175,827.137 kgs of U-308.

3) Transportation and Route Schedule

The vessel is scheduled to sail from Adelaide on October 08, 2012. The ocean transportation from Adelaide to Tacoma, WA USA will be the responsibility of Hapag Lloyd. The vessel will unload at Tacoma, WA USA on or about November 02, 2012. The inland transportation from Tacoma, WA to Blind River, ON will be the responsibility of RSB LOGISTIC SERVICES, INC.
