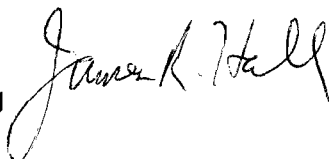

PURPOSE: The purpose of the meeting is to discuss the U.S. Nuclear Regulatory Commission (NRC) staff's review of Southern California Edison's (SCE's) October 3, 2012, response to the NRC's March 27, 2012, Confirmatory Action Letter for San Onofre Nuclear Generating Station, Unit 2. The NRC staff issued Requests for Additional Information (RAIs) to SCE on December 26, 2012, and February 1, 2013 (the latter RAI included proprietary information). This meeting will include discussions on the licensee's responses to the RAIs, the status of any outstanding questions from those RAIs, and any additional questions issued by the NRC staff prior to the meeting.

CATEGORY 1:* This is a Category 1 Meeting. The public is invited to participate in this meeting and will have one or more opportunities to communicate with the NRC after the business portion, but before the meeting is adjourned. Proprietary information may be discussed during the meeting.
