SUBJECT: ACCEPTANCE REVIEW OF SOUTH CAROLINA ELECTRIC & GAS COMPANY'S REQUEST FOR LICENSE AMENDMENT (LAR 13-03) FOR THE VIRGIL C. SUMMER NUCLEAR STATION UNITS 2 AND 3: TURBINE BUILDING ECCENTRIC AND CONCENTRIC BRACING (RQ0310 AND RQ0311)

Dear Mr. Jones:

By letter dated February 7, 2013 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML13042A003) and revised by letter dated February 14, 2013, (ADAMS Accession No. ML13050A603), South Carolina Electric & Gas Company (SCE&G) submitted a license amendment request (LAR) for the Virgil C. Summer Nuclear Station (VCSNS) Units 2 and 3. The proposed license amendment request would depart from the plant-specific Design Control Document (DCD) Tier 1 and Tier 2 material by allowing the use of eccentric and concentric bracing in the Turbine Building main area and modifying the design code.

SCE&G has also requested an exemption from the provisions of Title 10 of the *Code of Federal Regulations* (10 CFR) Part 52, Appendix D, Section III.B, "Design Certification Rule for the AP1000 Design, Scope and Contents," to allow a departure from the elements of the certification information in Tier 1 of the generic DCD.

The purpose of this letter is to provide the results of the U.S. Nuclear Regulatory Commission (NRC) staff's acceptance review of this LAR. The acceptance review was performed to determine if there is sufficient technical information in scope and depth to allow the NRC staff to complete its detailed technical review. The acceptance review is also intended to identify whether the application has any readily apparent information insufficiencies in its characterization of the regulatory requirements or the licensing basis of the plant.

Consistent with Section 50.90 of Title 10 of the *Code of Federal Regulations* (10 CFR), an amendment to the license must fully describe the changes requested, and following as far as applicable, the form prescribed for original applications. Section 52.79 of the 10 CFR addresses content of technical information required. This section stipulates that the submittal address the design and operating characteristics, unusual or novel design features, and principal safety considerations.

The NRC staff has reviewed your application and concluded that it does provide technical information in sufficient detail to enable the NRC staff to complete its detailed technical review and make an independent assessment regarding the acceptability of the proposed amendment in terms of regulatory requirements and the protection of public health and safety and the environment. Given the lesser scope and depth of the acceptance review as compared to the detailed technical review, there may be instances in which issues that impact the NRC staff's ability to complete the detailed technical review are identified despite completion of an adequate acceptance review.
