By the referenced Order, dated January 31, 2013, the U.S. Nuclear Regulatory Commission (the NRC) consented to the proposed indirect transfer of control of Construction Authorization No. CAMOX-001 for the Mixed Oxide Fuel Fabrication Facility now being constructed at the U.S. Department of Energy Savannah River Site in Aiken, South Carolina. The indirect transfer would result from a proposed transaction whereby The Shaw Group Inc. (Shaw) would be acquired by and become a wholly owned subsidiary of Chicago Bridge & Iron Company N.V. (CB&I).

Section III of the Order requires that Shaw AREVA MOX Services inform the Director of the Office of Nuclear Material Safety and Safeguards, in writing, after receipt of all required regulatory approvals of the proposed indirect transfer, no later than one (1) business day prior to the closing of the proposed indirect transfer.

The purpose of this letter is to inform the NRC that all required regulatory approvals of the indirect transfer have been received, and Shaw and CB&I intend to close the transaction on February 13, 2013.
