SUBJECT: ACCEPTANCE REVIEW OF SOUTH CAROLINA ELECTRIC & GAS COMPANY'S
REQUEST FOR LICENSE AMENDMENT (LAR 13-06) FOR THE VIRGIL C.
SUMMER NUCLEAR STATION UNITS 2 AND 3: PRIMARY SAMPLING SYSTEM
(RQ0316 AND RQ0317)

Dear Mr. Jones:

By letter dated February 7, 2013 (Agencywide Documents Access and Management System (ADAMS) Accession No. ML13042A004), South Carolina Electric & Gas Company (SCE&G) submitted a license amendment request (LAR) for the Virgil C. Summer Nuclear Station (VCSNS) Units 2 and 3. The proposed license amendment request would revise the Primary Sampling System (PSS) configuration by: 1) replacing the PSS containment air return check valve with a solenoid-operated valve (SOV), and 2) redesigning the PSS inside-containment header and adding a PSS containment penetration.

SCE&G has also requested an exemption from the provisions of Title 10 of the *Code of Federal Regulations* (10 CFR) Part 52, Appendix D, Section III.B, "Design Certification Rule for the AP1000 Design, Scope and Contents," to allow a departure from the elements of the certification information in Tier 1 of the generic DCD.

The purpose of this letter is to provide the results of the U.S. Nuclear Regulatory Commission (NRC) staff's acceptance review of this LAR. The acceptance review was performed to determine if there is sufficient technical information in scope and depth to allow the NRC staff to complete its detailed technical review. The acceptance review is also intended to identify whether the application has any readily apparent information insufficiencies in its characterization of the regulatory requirements or the licensing basis of the plant.

Consistent with Section 50.90 of Title 10 of the *Code of Federal Regulations* (10 CFR), an amendment to the license must fully describe the changes requested, and following as far as applicable, the form prescribed for original applications. Section 52.79 of the 10 CFR addresses content of technical information required. This section stipulates that the submittal address the design and operating characteristics, unusual or novel design features, and principal safety considerations.
