By letter dated August 1, 2012, the Nuclear Regulatory Commission issued a Request for Additional Information (RAI) regarding unrestricted usage of AREVA fuel and permanent exemption to use M5 cladding.

The RAI letter requested a response within 30 days of receipt of the letter. The NRC requested via phone call that the SCE affidavit for Owen Thomsen be updated to reflect a more recent date.

- (f) The information contained in the Documents is vital to a competitive commercial advantage held by Westinghouse, SCE, and/or AREVA, would be helpful to their competitors, and would likely cause substantial harm to the competitive position of Westinghouse, SCE, and AREVA.



Based on my experience in the nuclear industry, I am aware that other companies also regard the type of information contained in the Documents as proprietary and confidential.

In accordance with the Westinghouse-AREVA-SCE NDA, the Documents has been made available to the NRC in confidence, with the request that the information contained in this Documents be withheld from public disclosure. The request for withholding the information from public disclosure is made in accordance with 10 CFR 2.390. The information qualifies for withholding from public disclosure under 10 CFR 2.390(a)(4) "Trade secrets and commercial or financial information."

In accordance with SCE's policies governing the protection and control of proprietary and confidential information, the information contained in the Documents has been made available, on a limited basis, to others outside Westinghouse, SCE and AREVA only as required in accordance with the Westinghouse-AREVA-SCE NDA.

9. SCE's policies require that proprietary and confidential information be kept in a secured file or area and distributed on a need-to-know basis. The information contained in the Documents has been kept in accordance with these policies.

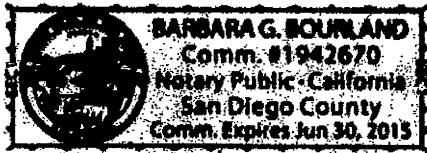
