2) Physical Description

This shipment will consist of 432 drums of Uranium Ore Concentrate (U-308) in 9 x 20' ocean containers. The total weight of the shipment is 158,597.884 kgs of U-308.

3) Transportation and Route Schedule

The vessel is scheduled to sail from Adelaide on November 05, 2012. The ocean transportation from Adelaide to Tacoma, WA USA will be the responsibility of **Hamburg Sud**. The vessel will unload at Tacoma, WA USA on or about November 30, 2012. The inland transportation from Tacoma, WA to Blind River, ON will be the responsibility of RSB LOGISTIC SERVICES, INC.
