SUBJECT: PLANNED INSPECTION OF TI-186 "INSPECTION OF PROCEDURES AND PROCESSES FOR RESPONDING TO POTENTIAL AIRCRAFT THREATS" AT DIABLO CANYON POWER PLANT, UNITS 1 AND 2

Dear Mr. Halpin:

In communications on January 16, 2013, Mr. S. Hedger, Operator Licensing Branch, and Mr. M. McCoy, Regulatory Services, made arrangements for the U.S. Nuclear Regulatory Commission (NRC) to conduct an inspection using Temporary Instruction (TI)-186, "Inspection of Procedures and Processes for Responding to Potential Aircraft Threats," at the Diablo Canyon Power Plant. This inspection is planned for the week of November 18, 2013. The NRC inspectors request to observe a tabletop or control room simulator exercise, combined with plant walkthroughs with plant operators to allow inspection of TI-186 attributes. Mr. M. McCoy has been advised of this request and provided with the name and address of the NRC lead inspector assigned to this inspection.

This letter contains information collections that are subject to the *Paperwork Reduction Act of 1995* (44 U.S.C. 3501 et seq.).
