In this proceeding, Sequoyah Fuels Corporation (SFC) and General Atomics (GA) have challenged an October 15, 1993 NRC staff order imposing certain conditions relative to the decontamination and decommissioning funding of SFC's Gore, Oklahoma facility. Currently pending before the Board is a November 18, 1993, motion for leave to intervene in this proceeding filed by the Native Americans for a Clean Environment (NACE), as well as December 6, 1993 responses to that motion filed by SFC and GA and a December 13, 1993 NRC staff response to that motion.
