ORDER

(Reply to Intervention Motion
Responses; Prehearing Conference)

In this proceeding, Sequoyah Fuels Corporation (SFC) and General Atomics (GA) have challenged an October 15, 1993 NRC staff order imposing certain conditions relative to the decontamination and decommissioning funding of SFC's Gore, Oklahoma facility. Currently pending before the Board is a November 18, 1993, motion for leave to intervene in this proceeding filed by the Native Americans for a Clean Environment (NACE), as well as December 6, 1993 responses to that motion filed by SFC and GA and a December 13, 1993 NRC staff response to that motion.

NACE may file a reply to the SFC, GA, and staff responses to its intervention motion on or before Thursday, December 30, 1993. If NACE files a reply during the week of

Further, a prehearing conference in this proceeding is scheduled for Wednesday, January 19, 1993, beginning at 9:30 a.m., in the NRC Hearing Room, Fifth Floor, West Tower, East West Towers Building, 4350 East West Highway, Bethesda, Maryland. At the conference, the Board will consider various matters regarding the conduct of this proceeding, including appropriate issues for litigation, discovery, and the timing and location of any evidentiary hearing.
