Response to OIG Recommendations

**Recommendation 1:** Establish an SGI laptop system and complete the process described in the NRC Laptop Security Policy for authorization of the SGI laptop system.

Agency Response: Agree. The Technical Training Center (TTC) is in the process of completing its certification and accreditation review and will be submitting a request for authority to operate (ATO) in the next few months. Issuance of the ATO will be tracked in the TTC plan of the week action tracking program.
