The purpose of this modification is to add incremental funding in the amount of \$540,000, therefore increasing the obligated amount from \$340,000 to \$880,000. A.2 Consideration and Obligation--Cost Plus Award Fee (AUG 2011) (c) of the contract is hereby changed to read: The amount obligated by the Government with respect to this contract is \$880,000. This modification also revises Section A.7 Contracting Officer's Representative (COR), replacing Christopher Markley with Jack Gwo (301-492-3178) as the NRC Task Order (TO) COR, and adding Deborah DeMarco as Alternate TO COR.
