SUBJECT: SUMMARY OF WEEKLY CONFERENCE CALL MEETING TO DISCUSS OPEN ITEMS AND OUTSTANDING REQUESTS FOR ADDITIONAL INFORMATION RESPONSES RELATING TO DTE ELECTRIC COMPANY'S FERMI 3 COMBINED LICENSE APPLICATION

On Thursday, January 31, 2013, the U.S. Nuclear Regulatory Commission's (NRC) staff held a public conference call from 1:00 pm to 2:00 pm with members of DTE Electric Company. The purpose of the conference call was to discuss the status of the remaining open items (OI) related to the Fermi 3 Combined License Application. A list of the agenda items, actions items discussed during the call and a list of attendees are below.

Agenda Items

1. Staff comments related to RAI Letter No 78 response - Fukushima Recommendation 4.2 – DTE Electric agreed to supplement their RAI response by revising their license condition to: 1) include a statement regarding compliance with procedures, guidance, training, and acquisition, staging, or installing of equipment needed for the mitigation strategies; 2) remove reference of "all units" since there is only one unit at Fermi 3; and 3) remove "for review" as the integrated plan will not be submitted for review and approval but provided as documentation for potential inspection activities– to be revised within 30 days (3/2/2013)
2. Staff comments related to RAI Letter No 78 response - Fukushima Recommendation 7.1 - DTE Electric agreed to supplement their RAI response by revising their license condition to remove "for review" as the integrated plan will not be submitted for review and approval but provided as documentation for potential inspection activities– to be revised within 30 days (3/2/2013)

Meeting Action Items:

1. Respond to Mr. Keegan's question: Under what portion of the Fukushima Order do Foundation and Soil Structure Analysis concerns get addressed with respect to Seismic Qualification and potential for liquefaction? What RAI addresses these concerns?

Could you please direct me to that documentation? – Email sent to Mr. Keegan and the Fermi Hearing File (publically available) on 2/4/2013 to address this question (attached) – Action complete
