Revised Schedule for Fermi Combined License Application

On February 15, 2013, the staff issued a revised schedule for the completion of the review of the Fermi 3 combined license application. Under the new schedule, the Final Safety Evaluation Report is projected to be issued in January 2015. This represents a 20-month schedule delay associated with the review of the soil-structure interaction analysis.

Category 2 Public Meeting on Risk-Informed Regulatory Framework for New Reactors

On February 5, 2013, the staff conducted a Category 2 public meeting to discuss specific aspects of the Commission's Staff Requirements Memorandum to SECY-12-0081, "Risk-Informed Regulatory Framework for New Reactors." Group participants discussed the technical basis for the use of deterministic backstops and/or relative risk measures, potential examples of appropriate backstops, and the appropriateness of the existing performance indicators and the related thresholds for new reactors.

Pre-licensing Meeting with Pacific Gas and Electric Company (PG&E)

On February 12, 2013, the staff held a pre-licensing public meeting with PG&E to discuss the licensee's plans to submit license amendment requests regarding degraded voltage protection and control room dose analysis for Diablo Canyon Power Plant, Units 1 and 2. These amendment requests would replace an October 24, 2011, license amendment request that was withdrawn via letter dated September 27, 2012. The licensee plans to submit amendments to revise its first level undervoltage relay technical specifications in June 2013, and to pursue approval of the alternate source term methodology in mid-2014.
