Dear Dr. Cordero:

On February 5, 2013, Thomas Thompson of this office conducted a safety inspection at the above address of activities authorized by the above listed NRC license. The inspection was limited to a review of circumstances surrounding the pharmaceutical preparation problems on January 8, 2013 that you reported to NRC on January 14, 2013. The findings of the inspection were discussed with you and Eduardo Diaz-Montes, R.Ph. of your organization at the conclusion of the inspection.

Within the scope of this inspection, no violations were identified, however, it was determined that several prepared doses labeled Cardiolite (Technetium-99m labeled imaging agent for heart studies) were prepared on January 8, 2013 that became degraded as a result of exceeding the manufacturer's recommended use time interval for the product prior to use by customers. We note that you have provided additional training and instituted the use of a warning banner that displays in the Radiopharmacy Management Information System (RMIS) computer display screen. The computer screen banner warns that the prepared pharmaceutical must be discarded if not used within an hour after preparation. Additionally, it is our understanding that you informed the Board of Pharmacy of this issue.
