On February 17, 1994, General Atomics moved that the Board temporarily stay discovery by all parties in this matter until the Board rules on General Atomics' Motion for Summary Disposition or for an Order of Dismissal.

Sequoyah Fuels Corporation ("SFC") agrees that all parties in this proceeding have a strong vested interest in minimizing litigation costs and that any discovery conducted by any party prior to the Board's ruling on the Motion for Summary Disposition could prove unnecessary and wasteful. SFC is particularly interested in the avoidance of unnecessary and wasteful discovery costs since it is important that SFC's assets not be diverted from their intended use in completing the decommissioning of SFC's facility.




