Thanks for the follow-up. We're prepared to perform the evaluation as suggested following development of the MU1 wellfield baseline package and submit this as a license amendment. Similarly, and more immediately, we are prepared to agree with the final license conditions but have not been able to access them on ADAMS. Ben and Mike,

I reconsidered your request to revise LC 11.3(a) for the first wellfield only and then have Strata, through the SERP process, perform an evaluation to reduce the minimum density of ore zone baseline wells for future wellfields. While I am sure that Strata will be able to perform such an evaluation, I did not revise the condition as requested. I have every confidence that after the first wellfield is complete and it can be shown that the reduction is warranted, Strata will complete an application to NRC for an amendment similar in quality as the license application which can be reviewed by staff in a timely manner. Consequently, I do not think this license condition poses a undue burden.

The clean version of the third draft license condition can be found in ADAMS with an Accession No. ML13057A516.

If Strata agrees or does not agree with the license conditions, please let me know in order to maintain completion of the Safety Evaluation Report within the established schedule.
