The US Army TACOM LCMC provides the following response to your questions concerning the subject SSDR approval.

Question 1 Answer. The design agency at Picatinny Arsenal, NJ for the M67 has not made any engineering changes to the M67 involving form, fit and function of the device per SSDR NR-0155-D-126-S dated 7 March 2006.

Question 2 Answer. The attached label is the data plate that identifies Seiler Instruments as the manufacturer of the m67 site unit. This data plate is attached to the m67 site. The cage code 11934 appears to the right of the part number 9356182.

In addition, M67's manufactured by ELCAN has cage code no. 36126 affixed to their label as well.
