NOTICE OF FORTHCOMING PUBLIC TELECONFERENCE TO DISCUSS STATUS OF  
WASTE CONFIDENCE GENERIC ENVIRONMENTAL IMPACT STATEMENT AND  
RULEMAKING (FSME-13-024)

**Purpose:** To inform all Agreement and non-Agreement States and State Liaison Officers of the opportunity to participate in a U.S. Nuclear Regulatory Commission (NRC) public teleconference on the status of activities related to the Waste Confidence rulemaking and preparation of the Generic Environmental Impact Statement (GEIS) that will support the revised Waste Confidence Rule.

**Discussion:** The public teleconference, sponsored by the Office of Nuclear Material Safety and Safeguards, will be held on **Wednesday, March 20, 2013, from 1:30 p.m. - 2:30 p.m.**, Eastern Daylight Time. The NRC Waste Confidence Directorate staff will provide an overview of the process and status of the project.
