REQUEST TO WITHDRAW LICENSE AMENDMENT REQUEST 244, PROPOSED
REVISION TO RADIOLOGICAL ACCIDENT ANALYSIS AND CONTROL ROOM
ENVELOPE HABITABILITY TECHNICAL SPECIFICATIONS

By application dated August 30, 2011 (Reference 1), Dominion Energy Kewaunee, Inc. (DEK), requested an amendment to Facility Operating License Number DPR-43 for Kewaunee Power Station (KPS). This license amendment request (LAR-244) would revise the KPS Operating License by modifying the Technical Specifications (TS) and the current licensing basis (CLB) to incorporate changes to the current radiological accident analysis (RAA) of record. This LAR was also intended to fulfill a commitment made to the NRC in response to Generic Letter 2003-01, "Control Room Habitability," (Reference 2) to submit proposed changes to the KPS TS based on the final approved version of TSTF-448, "Control Room Habitability."

On November 2, 2012, DEK notified the NRC that it intends to permanently cease power operations at KPS (Reference 3). Accordingly, since the plant is anticipated to be shutdown and defueled in the second quarter of 2013, DEK will no longer need NRC approval of this LAR and requests that it be withdrawn.

Withdrawal of LAR-244 will have no adverse effect on current or future operation of KPS. Submittal of LAR-244 was intended (in part) to fulfill a commitment made in 2005 associated with a response to Generic Letter 2003-01. However, once DEK has defueled the KPS reactor, there will be no reason to implement the TS and RAA changes proposed in LAR-244. DEK will continue to operate the plant under the current radiological analyses and in accordance with an existing operability evaluation until the plant is defueled and new accident analyses are approved which reflect the defueled status of the plant.

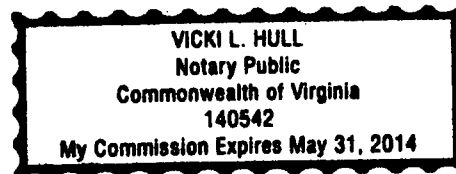
