Enclosed is Amendment No. 14 to your NRC Material License No. 24-00513-39 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

**This amendment also includes the renumbering of your License Conditions, which were incorrectly numbered on Amendment No. 13. We apologize for the error and for any inconvenience it may have caused you.**

**In addition, we enhanced the possession limit shown in Subitem No. 8.G on the license in order to express its value in units of curies, as well as grams. This enhancement facilitates alignment with NRC's Sensitive Unclassified Non-Safeguards Information (SUNSI) criteria and Increased Controls criteria.**

**In the future, for amendments and renewal of your license, for those radionuclides subject to SUNSI and/or Increased Controls criteria, please provide possession limit requests in both units of grams and curies. Your assistance in this regard will be greatly appreciated.**
