

No. 24 to Facility Operating License No. DPR-68, issued to Tennessee Valley Authority (the licensee), which revised Technical Specifications for operation of the Browns Ferry Nuclear Plant, Units Nos. 1, 2 and 3, located in Limestone County, Alabama. The amendments are effective as of date of issuance.

The amendments change the Technical Specifications and authorize the licensee to substitute a computational thermal model for in-situ temperature monitoring stations to determine compliance with the mixing zone temperature limits and the State of Alabama water temperature standards.

The application for the amendments complies with the standards and requirements of the Atomic Energy Act of 1954, as amended (the Act), and the Commission's rules and regulations. The Commission has made appropriate findings as required by the Act and the Commission's rules and regulations in 10 CFR Chapter I, which are set forth in the license amendments. Prior public notice of these amendments was not required since the amendments do not involve a significant hazards consideration.

The Commission has prepared an environmental impact appraisal for these amendments and has concluded that an environmental impact statement for this particular action is not warranted because there will be no environmental impact attributable to the action other than that which has already been predicted and described in the Final Environmental Statement for the facility dated September 1, 1972.

### Regulatory Guide; Withdrawal of Regulatory Guide and Issuance of Technical Report

The Nuclear Regulatory Commission has withdrawn Regulatory Guide 1.104, "Overhead Crane Handling Systems for Nuclear Power Plants," which was issued for comment in February 1976. It was originally developed to describe the special features and safety devices that should be added to standard overhead crane systems to make them single-failure proof for use in reactor refueling and spent fuel handling operations. Since the guide was issued, there has been a change in the need for guidance on the single-failure-proof option for handling heavy loads over or near the spent fuel pool, and it was decided to withdraw the guide and publish the information it contained in a technical report. The report, NUREG-0554, "Single-Failure-Proof Cranes for Nuclear Power Plants," reflects the comments and suggestions received on the guide. NUREG-0554 is available for public inspection at the Commission's Public Document Room, 1717 H Street, NW., Washington, D.C., or may be purchased at current rates from the National Technical Information Service, Springfield, Virginia 22161. Regulatory guides may be withdrawn when they are superseded by the Commission's regulations, when equivalent recommendations have been incorporated in applicable approved codes and standards, or when changes in methods and techniques or in the need for specific guidance have made them obsolete.
