By letter dated December 3, 2012 (Agencywide Documents Access Management System (ADAMS) Accession No. ML12359A060), you applied for an amendment to Donald C. Cook Nuclear Plant, Units 1 and 2, Renewed Operating License Nos. DPR-58 and DPR-74. The proposed change would have modified Emergency Action Levels (EALs) CG7, CS7, and CA7, of the EAL Scheme. By letter dated February 22, 2013 (ADAMS Accession No. ML13101A130), you requested to withdraw the license amendment request, as well as the EAL scheme that had been approved by the U.S. Nuclear Regulatory Commission on February 10, 2012 (ADAMS Accession No. ML12013A164), but had not been implemented.

The purpose of this letter is to advise that the December 3, 2012, application and the above-cited EAL Scheme change are being treated as withdrawn. Notice of Consideration of Issuance of the proposed amendment had not been published in the *Federal Register*.
