**Subject: DCD Markups Associated with Updated Seismic Closure Plan for US-APWR  
Seismic and Structural Analyses**

**Reference:** 1) Letter MHI Ref. UAP-HF-13034 from Y. Ogata (MHI) to U.S. NRC,  
"Updated Closure Plan for US-APWR Seismic and Structural Analyses -  
Schedule Improvement," dated February 15, 2013

With this letter, Mitsubishi Heavy Industries, Ltd. (MHI) transmits to the U.S. Nuclear Regulatory Commission (NRC) the DCD markups scheduled for submittal in February 2013 in Table 3 of Reference 1. The applicable DCD Sections are identified in Attachment 1 which includes the reason for the change.

This document includes certain information designated, pursuant to the Commission guidance, as sensitive unclassified non-safeguards information referred to as security-related information (SRI) that is to be withheld from public disclosure under 10 C.F.R. § 2.390. The information that is SRI is identified by brackets "[ ]". The non-proprietary (public) version of the document omits the SRI and is suitable for public disclosure. In the public version of the document, the SRI is replaced by the designation "Security Related Information – Withheld Under 10 C.F.R. 2.390."

Although identified in Table 3, "Impact on DCD," of Reference 1, the following DCD sections are not being changed at this time:

1. Tier 1, Sections 2.2.1, 2.2.1.3, and 2.2.1.8: Changes in descriptions of R/B complex, including PS/B, A/B, and AC/B basemats, have been determined to be unnecessary.
2. Tier 1, Section 2.2.3.1 (items 9 – 14): Updates (items 9 – 14) to address watertight doors between structures on the common basemat have been determined to be unnecessary.
3. Tier 1, Table 2.2-1: The R/B and PS/B in Table 2.2-1 includes the ESWPC, thus adding another row for the ESWPC alone was unnecessary.
4. Chapter 3, Table 3.2-4: This table's revision was unnecessary because it directly references Tier 1, Table 2.2-1, which remains unchanged.

5. Chapter 3, Section 3.4.1.3: This section will be revised as part of the RAI 841 response (related to Flooding analysis), and is not included with this letter.
6. Chapter 17, Table 17.4: This table is not being changed at this time because the internal fire and internal flooding PRAs that it is referencing in DCD Chapter 19, will not be changed.
7. Chapter 19, Sections 19.1.5.2 and 19.1.6.3: This section is not being revised because the difference in internal fire CDF due to the layout change was less than 5% of the cumulative CDF reported in DCD Rev. 3. The effects from the layout change and other changes (i.e. from RAI responses), will be incorporated by the end of Phase 4 of the DCD review.
8. Chapter 19, Sections 19.1.5.2 and 19.1.6.3: This section is not being revised because the difference in internal flooding CDF due to the layout change was less than 1% of the cumulative CDF reported in DCD Rev. 3. The effects from the layout change and other changes (i.e. from RAI responses), will be incorporated by the end of Phase 4 for DCD review.
9. Chapter 19, MUAP-07030 Rev. 3: This section is not being revised because the PRA in DCD Chapter 19 is not being revised at this time. This technical report will be revised after the DCD PRA is revised.
