The final change of ownership and name will be effective on March 1, 2013

- 1) The new name for the license activity will be Taghleef Industries Inc., 3600 East Head Road, Rosedale, Indiana 47874.
- 2) The contact information for licensee will remain the same.
- 3) There are no changes to the personnel controlling the radioactive material or license locations. Specifically the Vice President of Manufacturing, RSO, and Authorized Users for this license are the same as currently identified on the license, license conditions or application.
- 4) The transferor will not remain in business nor be a part of this license or in this use of radioactive material.
- 5) The transfer will be by a total sale of all stocks and bonds to the new owner.
- 6) There are no planned changes in the organization, location, facilities, equipment, procedures or personnel that would require a license amendment even without the change of ownership. There is no need to change the current emergency procedures.
- 7) There are no changes planned or pending in the use, possession, location or storage of the licensed materials.
- 8) There are no changes in the organization, location, facilities, equipment, procedures or personnel that would require a license amendment even without the change of ownership. There is no need to change the current emergency procedures.
- 9) All radiation licensed files are current, (e.g., calibrations, leak tests, surveys, inventories, and accountability requirements). Records are kept on site in the RSO's office. Confirm that all records of the license will remain in the possession of the new licensee in accordance with applicable regulations.

10) The facility is still in operation as allowed under the license. Activities on site are well below the license limits. Semi-annual surveys demonstrate that contamination levels are well below any working regulatory limits.

11) There are no plans to conduct decontamination efforts since the current levels are minimal. The current uses and amounts do not require any special financial assurance requirements. The transferee accepts full liability for the licensed use areas in the condition that they are found during the process of changing the ownership.

12) Confirm that the transferee agrees to abide by all commitments and representations previously made to NRC by the transferor. These include, but are not limited to: maintaining decommissioning records, implementing decontamination activities and decommissioning of the site, and completing corrective actions for open inspection items and enforcement actions.

13) Confirm that the transferor and transferee agree to the change in ownership or control of the licensed material and activity, and the conditions of transfer; and the transferee is made aware of all open inspection items and its responsibility for possible resulting enforcement actions.

14) Transferee commits to abide by all constraints, conditions, requirements, representations, and commitments identified in the existing license. If not, the transferee must provide a description of its program, to ensure compliance with the license and regulations.
