Re: Appointment of University Radiation Safety Officer

Dear Marwan:

It has come to my attention that IUPUC is in possession of a license with the U.S. Nuclear Regulatory Commission (NRC) for certain uses of radioactive material in research and teaching. In order to improve oversight of such activities, I recently expanded the role of Greg Crouch, who up to this point has been the Bloomington campus Radiation Safety Officer, to serve as University Radiation Safety Officer. His authority covers any such uses of radioactive materials at IU Bloomington and on the IU regional campuses, other than uses conducted under the auspices of the School of Medicine. Mack Richard in the Office of Research Administration continues to be responsible for all uses of radioactive materials and radiation producing devices on the IUPUI campus and at regional health organizations administered by the IU School of Medicine. Although IUPUC is an academic center of IUPUI, and would otherwise be part of Mr. Richards' responsibilities, the type of license and non-medical uses found at IUPUC are more similar to those of the regional campuses. Therefore, Mr. Crouch is better situated to handle the quantities and uses of radioactive materials at IUPUC.

As University Radiation Safety Officer, Mr. Crouch's responsibilities include representing IUB and regional campuses on all licensing and enforcement issues involving NRC; reviewing and determining the conditions for approval of all research projects involving the use of radioactive material or radiation-producing devices; providing radiation safety training to staff and students; conducting periodic audits of approved projects and determining corrective actions for any problems noted; verifying the implementation of corrective actions, managing the disposal of any radioactive waste generated; and ensuring compliance with the conditions of the university's nuclear materials license with NRC and with all other federal and state regulations pertaining to the use of sources of ionizing radiation. In particular, please note that *the University Radiation Safety Officer has the authority to immediately stop any operation involving radioactive material or a radiation-producing device that threatens the health and safety of students, faculty, staff, or others or that may result in noncompliance with relevant regulations.*
