The purpose of this modification is to terminate for convenience the remainder of this task order at no additional cost to the government. This modification also deobligates funds in the amount of \$38,072.48 and decreases the task order ceiling by \$66,883.13. The period of performance of this task order is also reduced to expire on December 28, 2012. Accordingly, the task order is modified as follows:

1. Section A.2 entitled: "Task/Delivery Order Period of Performance (AUG 2011) is revised to read as follows:
"This order shall commence on 03-01-2012 and will expire on 12-28-2012.
2. Section A.3 entitled: "Consideration and Obligation –Cost Plus Fixed Fee (AUG 2011) Alternate I (AUG 2011) is revised to read as follows:
 - (a) The total estimated cost to the Government for full performance of this task order is \$116,927.52, of which the sum of \$110,308.96 represents the estimated reimbursable costs, and of which \$6,618.56 represents the fixed-fee.
 - (b) There shall be no adjustment in the amount of the Contractor's fixed fee.
 - (c) The amount currently obligated by the Government with respect to this task order is \$116,927.52, of which the sum of \$110,308.96 represents the estimated reimbursable costs, and of which \$6,618.56 represents the fixed-fee.
3. This supplemental agreement settles the settlement proposal resulting from the Notice of Termination dated January 24, 2013.
4. The following Release shall be signed by the contractor as part of this modification.

3. Claims for reimbursement of costs (other than expenses of the Contractor by reason of his indemnification of the Government against patent liability), including reasonable expenses incidental thereto, incurred by the Contractor under the provisions of the said contract relating to patents.

The Contractor agrees, in connection with patent matters and claims which are not released as set forth above, that he will comply with all of the provisions of the said contract, including without limitation those provisions relating to notification to the Contracting Officer and relating to the defense or prosecution of litigation.
