I strongly urge you to support a reasonable and prompt process for the reopening of the San Onofre Nuclear Generation Station.

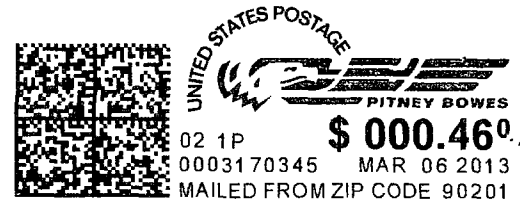
