Inspection activities charged to these reports include conducting mid-cycle/end of cycle assessment activities, responding to technical questions from resident inspectors or licensee personnel, and resident baseline inspection. On December 31, 2012, the NRC staff also completed its annual inspection of the Security Program at Peach Bottom Atomic Power Station. This inspection began on January 1, 2012. Issuance of this letter closes Inspection Reports 05000277/2012401 and 05000278/2012401. Inspection activities charged to these reports include conducting end of cycle assessment activities, following up on Suspicious Incident Database reports, responding to technical questions from resident inspectors or licensee personnel, and, in some cases, performing traditional enforcement activities. Any observations and findings in this area were provided to you via separate correspondence.


