Enclosed is Amendment No. 35 to your NRC Material License No. 21-01432-02 in accordance with your request. Please note that the changes made to your license are printed in **bold font**.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.

This also refers to the telephone discussion between you and me on March 4, 2013, concerning the bounding (by stating the lowest and highest atomic numbers for these materials) needed at this time for materials authorized under Subitem No. 6HH. of the license.

In your letter dated March 6, 2013, you indicated that the researcher you need to consult with about this matter is unavailable but that you expect to be able to submit this information to us by approximately April 3, 2013.

Please submit this information to my attention as "additional information to control number 579631," to facilitate proper handling in our offices. Only one complete copy is needed and should be submitted, that should also be currently dated and signed by a senior management representative. Your assistance in this matter is greatly appreciated.

In your letter dated March 6, 2013, you requested the deletion of a particular room in the Cart Building, as no licensed materials had ever been possessed, used or stored in this room. This room is now considered released for unrestricted use. The deletion of this room has been completed at this time and it has been replaced on your license, as requested, in accordance with your application dated December 18, 2012, and your letter dated March 6, 2013.

This could include issuance of a notice of violation, or imposition of a civil penalty, or an order suspending, modifying or revoking your license as specified in the General Statement of Policy and Procedure for NRC Enforcement Actions.

Since serious consequences to employees and the public can result from failure to comply with NRC requirements, prompt and vigorous enforcement action will be taken when dealing with licensees who do not achieve the necessary meticulous attention to detail and the high standard of compliance which NRC expects of its licensees.
