SUBJECT: TERMINATION OF NRC RADIOACTIVE MATERIALS LICENSE

By correspondence received on February 28, 2013, you informed the Nuclear Regulatory Commission (NRC) of the licensee's decision to terminate NRC radioactive materials license number 53-15984-01. In support of this request, you submitted NRC Form 314 dated February 21, 2013. Form 314 stated that all radioactive material in sealed source form had been transferred to a licensed entity and that all radioactive material has been removed from your facility. The supporting documentation also provided copies of leak test results and a decommissioning survey of your facility. The leak test results document that there was no evidence of leakage of radioactive material from the sealed sources that were in your possession. In addition, the decommissioning survey documents that there is no residual radioactivity remaining in your facility as a result of using short lived radioactive material.

Based on the documentation submitted and a review of your historical file, the staff concluded that all licensable radioactive material has been removed from your facility and that the facility located at 1380 Lusitana Street, Suite 902, Honolulu, Hawaii, is suitable for unrestricted use in accordance with 10 CFR 20.1402, "Radiological Criteria for Unrestricted Use." Based on these conclusions, no further remediation or actions with respect to NRC regulated material is required.

Please find enclosed amendment number 08 to license number 53-15984-01 authorizing your license termination. An environmental assessment for this action is not required since this licensing action is categorically excluded under 10 CFR 51.22(c)(14)(iv).
