Purpose

Pursuant to Reference 1, the American Centrifuge Operating, LLC (ACO) hereby submits cyber security plans and security test and evaluation (STE) results to the U.S. Nuclear Regulatory Commission (NRC) to complete the accreditation of the following plans:

- SP-2605-0027, *Information System Security Plan (ISSP) for Interconnected Classified Networks Processing Classified Information at Protection Index = 2*
- SP-3605-0002, *Classified Data Processing Network Information System Security Plan (ISSP) Processing Classified Information at Protection Index PI-2*
- SP-3605-0003, *Lead Cascade Distributed Control System Information System Security Plan (ISSP) Processing Classified Information at Protection Index PI-2*

Background

On January 11, 2011 (Reference 2), the NRC provided guidance related to classified computer network cyber security plans. Plan-specific definitions were incorporated into Chapter 2.0 of the NR-3605-0004, *Security Program for the American Centrifuge Plant*, to address this guidance as approved by the NRC in Reference 1.

Discussion

Subsequent to the NRC's approval on February 8, 2013 (Reference 1) minor, non-substantial changes as defined by Reference 2 and NR-3605-0004 have also been made to these plans. These minor, non-substantial changes have little or no impact to the current operational status or security posture of the systems. These changes are administrative in nature and include the following: 1) the removal of specific names for approval of these cyber security plans due to changes in personnel; 2) revised the Authorizing Official from "DOE DAA" to "DOE/NE-ORSO" as discussed in Reference 1; 3) removed the footnote within Section 2; and 4) changed the revision number and effective date to reflect these most recent changes and issuance of the approved cyber security plans for the NRC's review and approval. Current and previously approved changes to these plans are designated with a revision bar in the right hand margin.

Enclosure 1 of this letter provides SP-2605-0027, Revision 5, dated February 2013. Enclosure 2 of this letter provides SP-3605-0002, Revision 2, dated February 2013. Enclosure 3 of this letter provides SP-3605-0003, Revision 2, dated February 2013. Enclosure 4 of this letter provides SP-3605-0002, STE Results. Enclosure 5 of this letter provides SP-3605-0003, STE Results.

Enclosures 1 through 5 contain Security-Related Information and in accordance with the guidance provided by the U.S. Department of Energy (DOE), these enclosures also contain Official Use Only information. Therefore, ACO requests these enclosures be withheld from public disclosure pursuant to 10 CFR 2.390(d)(1).

Action

ACO respectfully requests that NRC review and approval of these cyber security plans be completed at your earliest convenience to allow the reaccreditation of these systems until January 1, 2015 as defined within Reference 1.

ACO respectfully requests that any NRC and/or DOE inspection and accreditation of these proposed changes be completed by March 25, 2013 to allow timely operation of the DCS to support the deployment of a Commercial Demonstration Cascade.
