Subject: Visit to Palisades - topics

Patty, I'm not sure if we already have briefing material for this trip but the following might be worth considering for inclusion... Let me know and I'll follow up with the EDO's office.

I recommend the following for discussion with the Resident Inspector and possibly the utility or plant management:

- Palisades was prominently featured in the recent UCS annual report for an Aug 2011 reactor coolant pressure boundary leak from the control rod drive system. The source of the small leak (0.3 gallons per minute as measured in sumps in the building) went unidentified for 28 days. Tech specs require that the

plant shut down within 6 hours for reactor coolant pressure boundary leaks – zero leakage is allowed. That did not happen since the leak was categorized as “unidentified” which allows for a leakage rate of 1 gallon per minute. Since there is no direct, installed method to identify this type of leak, and it is not at all common, the plant’s assumption – although wrong – is understandable. UCS is concerned both about the plant’s failure to identify and act upon the leak, as well as the NRC’s response – or lack thereof. UCS would have preferred the maximum \$140,000 per day (total \$3.9 Million) fine been imposed for the full 28 days that the plant was unknowingly in violation of their tech specs.

- February 2012 shutdown – caused by a leak in a component cooling water system that could not be corrected in the 72 hours allowed by the technical specifications. Resolved.
- FLEX – no issues, but might be good to pulse them on their understanding of the requirements
