Reference: G. Gibson (UniStar Nuclear Energy) to U.S. Nuclear Regulatory Commission (NRC), "Response to Request for Additional Information for the Calvert Cliffs Nuclear Power Plant, Unit 3, RAI No. 75", UN#09-211, dated May 8, 2009 (ML091320329)

The purpose of this letter is to identify changes that will be made to the PPL Bell Bend, LLC (PPL) Bell Bend Nuclear Power Plant (BBNPP) Combined License Application (COLA) and the endorsement of a provided response included in the responses made to the Request for Additional Information (RAI) by the Calvert Cliffs Nuclear Power Plant (CCNPP) Unit 3; the Reference COLA (RCOLA).

In response to CCNPP Unit 3 RAI No. 75, Questions 09.05.01-1 and 09.05.01-11 (Reference), CCNPP Unit 3 identified necessary changes to the RCOLA. These RCOLA changes are also applicable to the BBNPP COLA. Changes that retain the intent of the RCOLA reference changes, but are modified so as to be consistent with the format and content of similar BBNPP compliance statements, will be incorporated into a future revision of the BBNPP COLA.


The only new regulatory commitment in this letter is to update the BBNPP COLA at a future date.
