This is to inform you of the appointment of Mr. Binesh Tharakan to the position of State Agreements Officer for the U.S. Nuclear Regulatory Commission (NRC), Region IV office in Arlington, Texas. Mr. Tharakan is appointed to fill the position previously held by Ms. Rachel Browder, who is now a Senior Enforcement Specialist in the Region IV office.

Mr. Tharakan joined the NRC in 1999 as a health physicist in the NRC Headquarters' office. He transferred to the Region IV office in 2003 as a health physicist, holding various positions, including nuclear systems engineer and resident inspector. Prior to joining the NRC, his work experience included a radiological engineering consultant for Westinghouse, a dosimetry laboratory manager for Health Physics Northwest, a graduate research fellow at Department of Energy's (DOE's) Argonne National Laboratory West, and a health physicist at Oregon State University Radiation Center. Mr. Tharakan received his B.S. degree in Radiation Health Physics in 1993 from Oregon State University Nuclear Engineering and M.S. degree in Health Physics in 1997 from Texas A&M University. Mr. Tharakan received his certification from the American Board of Health Physics in 2006.
