Subject: Supplement to Administrative Amendment 36 to GESTAR II to Incorporate Revision 7 of the DSS-CD LTR into GESTAR II US Supplement

This is a supplement to GESTAR II Administrative Amendment 36 (Reference 1) to incorporate Detect and Suppress Solution – Confirmation Density (DSS-CD) applications based on NEDC-33075P Revision 7 (Reference 2) into the GESTAR II US process.

This administrative amendment restates aspects of the method approved in the DSS-CD licensing topical report (LTR). Both the Revision 6 (Reference 3) basis and the Revision 7 (Reference 2) basis will be retained in the GESTAR II US Supplement for the near term until all licensees make the change to Revision 7 of the DSS-CD LTR.

Sections S.1.3, S.4, S.4.1.5, S.4.2.3, S.4.2.4, S.5.2.4, and S.6 in the US Supplement to GESTAR II are affected by this amendment. All changes are shown in revision mode to ease the review.

It is requested that the NRC review and approve this proposed supplement to Administrative Amendment 36 concurrent with the approval and issuance of the final Safety Evaluation (SE) for Administrative Amendment 36.
