This is in reference to your letter dated January 10, 2013, in which you requested an extension of 90 days to complete a Decommissioning Funding Plan Cost Estimate (DFP) and the Certification of Financial Assurance (CFA) for Nuclear Regulatory Commission License No. 08-01738-02. After review, it has been determined that a 90-day extension will not be granted since there was advance notice of the requirement to submit a DFP and revised CFA in December 2012. Please provide the requested documents within 30 (thirty) days of the date of this letter.
