Hello Annette,  
Maryland is indeed interested in replenishing its supply of 130 mg KI tablets, which will expire in 2014. Thank you very much for assisting the NRC in again providing the replacement doses. Maryland would be most appreciative to receive 400,000 tablets of 65 mg KI tablets to replace the 197,720 tablets of 130 mg KI tablets that will go out-of-date in February 2014.

Please have your freight handler deliver the replenishment KI tablets directly to the Emergency Operations Center rollup bay door in the single-story North Building of our Montgomery Park Campus [the second, GREEN Lot Monroe Street entrance], rather than having the several pallets delivered to the main loading dock in our multi-story Headquarters Building [the first, RED Lot Monroe Street Entrance. MDE accepts deliveries between the hours of 8 a.m. and 5 p.m.

Hello,

The NRC is preparing to replenish expiring stockpiles of KI tablets. According to our records your State has 197,720 (130mg) tablets with lot numbers PO3-9, expiring in February 2014. We are no longer supplying (130mg) tablets and will be replacing stockpiles with (65mg) tablets (2 per adult and 1 per child). We will replace your (130mg) tablets with 400,000 (65mg) tablets. The NRC will replace the expiring stockpiles during fiscal year 2014. If your State wishes to participate in the NRC KI tablet replenishment, please respond with the delivery address, point of contact (including phone number) and any special delivery requests you have no later than May 31, 2013. Please note these tablets will not be shipped until 2014 to ensure timely replacement of your States expiring KI stockpiles. We will notify you prior to shipment of the tablets to enable you to make any preparations necessary for receipt of the shipment.
