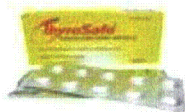

Hello Annette,

Thank you for your email! Deb retired in October of 2012, and I have replaced her as of January.

I do have a few questions regarding replenishment of Potassium Iodide (KI).

1. How will the KI be packaged? Do you have a sample that we could see and use for our distribution planning purposes?



Each package contains 20 tablets. I have attached Packaging and Pallet information to this e-mail. Please know the picture above is a sample of what we have used in the past. We currently do not have a contract so package might not be exactly the same.

2. Will we be able to receive the KI before February of 2014? Our goal is to send the KI to the States before current tablets expire. At this time, I can't an actual date as we don't have a contract yet. We wanted to distribute the new KI before the old one expires.
3. What is the expiration date of the replenishment stock? I will not have that information until we have a contract in place with a vendor. We are in the process of obtaining a new contract.

We can receive the KI at our facility at 269 Maxim Road, in Hartford, CT 06114. We will need to know how many boxes or pallets there will be so we can ensure that someone is there to receive it. That would be 10 pallets, please know they can be double stacked, see attachment with dimensions.

Hello,

The NRC is preparing to replenish expiring stockpiles of KI tablets. According to our records your State has 370,000 (130mg) tablets with lot numbers PO3-6 expiring in February 2014 and 270,000 tablets, lot number PO3-9 that will expiring in April 2014. We are no longer supplying (130mg) tablets and will replace stockpiles with (65mg) tablets (2 per adult and 1 per child). We will replace your (130mg) tablets with 1,280,000 (65 mg) tablets. The NRC will replace the expiring stockpiles during fiscal year 2014. If your State wishes to participate in the NRC KI tablet replenishment, please respond with the delivery address, point of contact (including phone number) and any special delivery requests you have no later than May 31, 2013. Please note these tablets will not be shipped until 2014 to ensure timely replacement of your States expiring KI stockpiles. We will notify you prior to shipment of the tablets to enable you to make any preparations necessary for receipt of the shipment.
